

### The Object of the Assembly

From the Constitution of the General Assembly as amended 19 April 2001 and approved by the Charity Commission:

#### "2.Object

#### Preamble

We, the constituent congregations, affiliated societies and individual members, uniting in a spirit of mutual sympathy, co-operation, tolerance and respect; and recognising the worth and dignity of all people and their freedom to believe as their consciences dictate; and believing that truth is best served where the mind and conscience are free, acknowledge that the Object of the Assembly is:

#### Object

To promote a free and inquiring religion through the worship of God and the celebration of life; the service of humanity and respect for all creation; and the upholding of the liberal Christian tradition.

To this end, the Assembly may:

Encourage and unite in fellowship bodies which uphold the religious liberty of their members, unconstrained by the imposition of creeds;

Affirm the liberal religious heritage and learn from the spiritual, cultural and intellectual insights of all humanity;

Act where necessary as the successor to the British and Foreign Unitarian Association and National Conference of Unitarian, Liberal Christian, Free Christian, Presbyterian and other Non-Subscribing or Kindred Congregations, being faithful to the spirit of their work and principles (see appendix to the constitution), providing always that this shall in no way limit the complete doctrinal freedom of the constituent churches and members of the Assembly;

Do all other such lawful things as are incidental to the attainment of the above Object."

In reference to second last clause of Object, the following is a statement of the Objects of the British and Foreign Unitarian Association, as set forth in Rule 2 of its Constitution:

The diffusion and support of the principles of Unitarian Christianity, including the formation and assistance of Congregations which do not require for themselves or their Ministers subscription to any doctrinal articles of belief; the publication and circulation of biblical, theological, scientific and literary knowledge related to Unitarian Christianity; the doing of all such other lawful things as are incidental or conducive to the attainment of the above objects or any of them.

The following is a statement of the Objects of the National Conference of Unitarian, Liberal Christian, Free Christian, Presbyterian and other Non-Subscribing or Kindred Congregations, as set forth in Rule 1 of its Constitution:

To consult, and when considered advisable to take action, on matters affecting the well-being and interests of the Congregations and Societies on the Roll of the Conference, as by directing attention, suggesting plans, organising expressions of opinion, raising funds to carry out the foregoing objects.

The seventy-fifth Annual Meetings of the General Assembly of Unitarian and Free Christian Churches began on Sunday 13 April 2003 and ended on Wednesday 16 April 2003 and were held at the Riccarton Campus, Heriot-Watt University, Edinburgh.

The Opening Business Session began with the parade of banners, a welcome from the General Assembly President, Alan Ruston. Devotions were conducted by the Rev Eric Breeze.

Councillor Marion Moreton, Depute Provost of the City of Edinburgh, brought the greetings of the City of Edinburgh. Interfaith greetings were brought by Mrs Ravinder Kaur Nijjar, Chairperson of the Scottish Interfaith Council.

Overseas representatives were recognised and welcomed. Those attending for all or part of the proceedings were Mary Bennett (Canadian Unitarian Council), the Rev Harrison Kingsley (Unitarian Church of Madras), Carleywell Lyngdoh (Indian Council of Unitarian Churches), the Rev William Sinkford (Unitarian Universalist Association of Congregations), and the Rev Dr Arpad Szabo (Unitarian Church of Transylvania). Other international visitors were asked to stand and be recognised.

Standing Orders for the Conduct of the Annual Business Meetings were adopted and Christine Hayhurst, Roderick Ramage and Dr David Wykes were confirmed as the members of the Steering Committee. Jane Aaronson delivered the keynote address on the theme "Unitarian address accessibility issues".

At the second business session the Annual Report was presented by the General Secretary. The Accounts for the year ended 30 September 2002 were presented by the Honorary Treasurer, Michael Tomlin and Finance and Administration Chairperson, Sir Peter Soulsby. Other committee reports were presented at the remaining business session by a variety of appropriate spokespersons. The Amy Howarth Rosebowl was awarded to the Congregation of York in recognition of their growth of quota-paying membership in 2002/2003.

#### RESOLUTIONS

The following resolutions were carried:

1) From the General Assembly Council
That this General Assembly of Unitarian and Free
Christian Churches is pleased to receive the
application for membership as a Provisional

Fellowship from *The Unitarian Fellowship of Durham* and welcomes it onto the General Assembly's Roll of Congregations.

#### 2) From Thirteen Full Members

That this General Assembly of Unitarian and Free Christian Churches instructs GA Council to appoint a task force to develop proposals to change the system of governance to have a nationally elected leadership, and to present them at the 2004 General Assembly.

#### 3) From the East Midland Unitarians

That this General Assembly of Unitarian and Free Christian Churches, whilst welcoming the generous grant from a charitable trust to continue a fortnightly edition of *The Inquirer* until August 2004, urges the Inquirer Board to seek ways to continue this commitment which we consider vital to the movement.

#### 4) From the Foy Society

That this General Assembly of Unitarian and Free Christian Churches, mindful of the importance of representative Annual Meetings to the vitality of our movement, instructs the General Assembly Council to set criteria for future Annual Meetings which will ensure that venues and pricing structures are selected which offer low cost options with a view to maximising attendance.

#### 5) From the Richmond and Putney Unitarian Church

That this General Assembly of Unitarian and Free Christian Churches, mindful of the danger to world peace from the stockpiling of weapons brokered through the international arms trade; noting the legislation passed by the British Government during the year 2002 with a view to government control of intended arms exports on the part of agents operating within British jurisdiction and regretting its incomplete range:

Calls on all members to support efforts by Oxfam, Amnesty International, the International Action Network on Small Arms and others to secure a new International Arms Trade Treaty to stop the flow of arms to potentially abusive regimes;

Welcomes the recent international conference convened by the British Government on arms control;

Urges Her Majesty's Government to strengthen its legislation and its implementation; And furthermore urges it, as representing the world's second largest arms-exporting country, to press for new international controls over arms sales.

#### 6) From the Midland Union

That this General Assembly of Unitarian and Free Christian Churches, recognising the uncertainty caused by the fundamental changes in Charity Law now envisaged by the Government, the threat to the continued existence of smaller congregations due to their aging memberships and the reduced financial and staffing capacity of Essex Hall to cope with tasks which could be undertaken without charge by the Charity Commission:

Urges every Congregation which has not already done so to take immediate steps to ensure that:

- 1. Its bookkeeping and Annual Report & Accounts fully comply with statutory requirements.
- 2. Its Constitution complies with best modern practice in defining the policies and procedures required to administer its affairs and in particular that this includes a Winding Up Clause guiding future trustees about the disposal of its assets in a manner designed to continue the work of the Unitarian Movement.

#### 7) From Twelve Full Members

That this General Assembly of Unitarian and Free Christian Churches affirms the importance of Ministry in the Unitarian Movement and the desirability of this being reflected in its structures. Accordingly, it requests the Council to ensure that the work of the Ministry Committee is continued in a unified way, either as a Ministry Commission, or, failing this, incorporated into one other Commission.

#### 8) From Sixteen Full Members

That this General Assembly of Unitarian and Free Christian Churches, mindful of the profound religious sensibilities aroused by the present war in Iraq, and conscious of the necessity of not exacerbating the situation further, expresses its deep concern at reports that some so-called "fundamentalist" and "evangelical" Christian organisations are planning to enter Iraq in the aftermath of war for the purposes of religious proselytization, and calls upon Her Majesty's Government and the Government of the United States to ensure:

 that the religious integrity of Iraq be fully respected by any post-war administration set up under the auspices of the United States and the United Kingdom.

- that the indigenous faith communities in Iraq, including both Muslim and Christian, be left free to practise their faith freely and without interference.
- 3. that any individuals or organisations intending to enter Iraq in the aftermath of war for the purposes of undertaking religious proselytization be prevented from doing so.
- 4. that humanitarian aid programmes not be used for the purposes of religious proselytization.
- 5. that the post-war administration place the utmost importance on the fostering of positive and constructive relationships with the indigenous faith communities of Iraq.

Furthermore, as Unitarians and Free Christians we dissociate ourselves unreservedly from any attempt to interpret the war in Iraq in terms of "Christian triumphalism" or the "fulfilment of biblical prophecy", believing such interpretation to be erroneous, irresponsible and dangerous.

9) From The Unitarian Peace Fellowship
That this General Assembly of Unitarian and Free
Christian Churches expresses its sorrow and deep
regret at the thousands of deaths and injuries,
civilian and military, suffered by victims of war in
Iraq; urges Her Majesty's Government to devote,
as a matter of extreme urgency, massive resources
to the emergency relief and succour of the Iraqi
people; and calls upon our congregations, as a
practical gesture of our own humanitarian
concern, to respond generously to the special
appeal administered by the Unitarian Peace
Fellowship for the life saving work in Iraq of Save
the Children.

- 10) That the thanks of the Assembly be given to Kerr Jamieson, organist for the Anniversary Service, and to local Unitarians who arranged other music for the Meetings.
- 11) That the thanks of the Assembly be given to all the local Unitarians, especially from the sponsoring district, the Scottish Unitarian Association, for their inestimable help in organising the Meetings.

# Report of Council

#### 1. Meetings

Council met four times during the year. Three meetings were of which were at Unitarian Headquarters, Essex Hall. The other was held immediately following the Annual Meetings at Heriot-Watt University, Edinburgh to enable timely decisions to be made by the newly appointed Council members.

#### 2. President

The Rev Austin Fitzpatrick became President at the Annual Meetings at the Heriot-Watt University on 16 April 2003.

#### 3. Nominations

The Council is pleased to nominate Dawn Buckle as President for 2004/2005, the Rev Brian Cockroft as Vice-President and Michael Tomlin as Honorary Treasurer. The post of Deputy Honorary Treasurer will continue to remain vacant.

#### 4. GA Resolutions

The Council, its departmental committees and officers have dealt appropriately with the resolutions passed at the GA Annual Meetings. Where appropriate, letters were sent to government bodies and others. Of particular note were the actions necessary to create the Task Force. Negotiations for its funding were carried out with the Bowland Charitable Trust and a working partly was created to recommend the Task Force membership to Council. This was finalised at the July meeting. Another motion demanding Council attention concerned the review of the Annual Meetings. This was also the subject of a working party which reported to Council. Council heeded to the motion by twelve members and agreed to modify the Commission structure to include a fifth Commission for Ministry.

#### 5. GA Theme

The two-year theme "Removing Barriers: Unitarians address disability issues" was adopted at the 2003 GA Annual Meetings.

# 6. Triennial Review Working Party (TRWP) and the creation of the Commissions and Panels

Following the revelation of the extent of the General Assembly's reduced finances, the TRWP was established at the Annual

Meetings 2002 and met three times between May and September 2002. It produced a report and recommendations for the November 2002 Council meeting. The recommendations were accepted in principle at that meeting but Council required more information before deciding the final details. The General Secretary was commissioned to produce a more detailed report. The February 2003 Council agreed to one aspect of the report, the establishment of the Administration Commission, but felt that it needed the goodwill of the Annual Meetings to agree the remaining proposals. A section of the business meetings was devoted to this at Edinburgh and, as noted under the Resolutions paragraph, an extra Commission, for Ministry, was requested. The April 2003 Council meeting appointed the members for the Administration Commission. The July 2003 Council appointed the membership for the remaining Commissions and Panels by secret ballot. This was an important departure from previous practice as it did not involve the services of a triennial selection panel. The Commissions will be transparent to Council because their minutes will be circulated to Council members. Details of the new structure appear elsewhere in this report.

#### 7. Unitarian Future Vision

A fundamental aspect of the revised structure will be the role of Commissions in future planning. Each Commission will commence with the development of a mission statement and future objectives. The Commissions with perform a review of the Panels and identify areas where change is necessary. The Administration Commission will have a particular responsibility to consider the overall strategy of the General Assembly. Council will remain the ultimate authority to approve the policies arising out of this process.

#### 8. General

District associations, affiliated societies, panels and committees provided detailed reports of their work. The GA committees kept members fully informed of their activities and current issues. The manner in which committees serve the movement is reported in the ensuing pages of this Annual Report. Council thanks all of those who served on its committees and panels during the year.

The downsizing of the GA Headquarters staff establishment has prevented the General Secretary from being actively involved. The Panel will be within the functional area of the Denominational Support Commission.

#### DEVELOPMENT COMMITTEE

The Unitarian Development Committee (UDC) held its final meeting in October 2003 and reviewed its current and most recent projects, namely: Small Congregations Consultancy (SCC); Fellowships Initiative Group (FIG); 21-45 age group; Engagement Group Support (EGS) and DSTP (Development Skills Training Programme). The UDC feel these projects have added value to the denomination and should, therefore, be continued.

The SCC has done valuable work in providing support for eight congregations. A questionnaire was sent to all these congregations, asking them to assess the effect of their three consultancy visits. The Congregational Consultancy Panel under the Denominational Support Commission (DSC) will be continuing this work. The DSTP network can provide facilitators for ongoing support of congregations.

FIG has produced three manuals to support the setting up of new Fellowships. Fellowships are appearing as frequently as congregations are closing. The UDC would like to see an interactive web-site set up to support Fellowships, who are often isolated by distance from congregations. The UDC would also like FIG to continue as a Panel (Fellowships Initiative Panel?) under the DSC.

21-45 age group. The UDC have been investigating what this age group want from the denomination. We would like this work to be continued by the DSC, in linking together all those groups currently involved with this age group. It is felt that collaboration between these groups (FOY, 18+, FIG, National Unitarian Fellowship, post YUC network and Associate Members) could lead to an active network of 21-45 year olds.

Six UDC members have been actively involved in EGS. Successful Engagement Group workshops took place at Hucklow Summer School in August 2003. Another Engagement Seminar for Engagement Group Facilitators is planned for June 2004. We hope that EGS can continue as a Panel (Engagement Support Panel?) under the DSC. Any training will need to be in collaboration between the DSC and the Education and Training Commission (ETC).

The UDC have run a number of successful DSTPs and would like see future DSTP training run every three years. Funds will have to be raised and the programme marketed internally and perhaps externally at some stage. UDC believe that DSTP should be a required element of Ministerial training.

There are many people in the denomination with specialist skills and experience in many areas who are willing to offer advice and support. The UDC recommend that the DSC, ETC and Outreach and Communications Commission (OCC) work together to create and maintain a skills database for the denomination.

1. Meetings

The Executive Committee met twice during the year, firstly in October 2002 and then in January 2003. The Committee ceased to exist after the GA Annual Meetings in April 2003 because its role was taken over by the Administration Commission. Until that date the Committee continued to function by email networking or correspondence in accordance with its established procedures.

2. The Work of the Executive Committee

The Committee heard routine reports from the President, Vice-President, Honorary Treasurer and General Secretary. For economy reasons and because of the proposed ending of its existence, the Committee continued to operate one person below establishment. The Committee continued to monitor the progress and workings of Unitarian Headquarters in regular report and via the summaries of the annual staff job review discussions. This included the initiation of the staff downsizing process. Elizabeth Obe commenced legal studies in October 2002 and negotiated part-time working arrangements resulting in an average of two days per week. The Rev John Clifford returned to ministry, leaving the GA in May 2003. Sarah Tinker left at the end of September 2003 to commence ministry studies. Neither were replaced. Neil MacPherson was absent through illness for several periods during the year.

#### 3. Special Attention

Matters receiving special attention were:

The Triennial Review Working Party – This was a dominant concern. The EC members were involved firstly in terms of the presentation of the recommendations to Council, then in terms of the development of the detail for the further report and finally in terms of its presentation to the Annual Meetings in Edinburgh.

Unitarian Future Vision – Bearing in mind the mandate granted by the western Union's strategic planning resolution, passed at the 2002 Annual Meetings, EC members made sure that Unitarian Future Vision was included as a fundamental part of the proposed Commission structure.

Essex Hall – The decision for the Unitarian Headquarters to migrate from the first floor to the ground floor and basement was a matter for planning and monitor.

Excepted status – The Home Office deliberations were monitored, particularly via

our representation on the Churches Main Committee.

# FINANCE & ADMINISTRATION COMMITTEE

Meetings:

The Committee met in November 2002 and then for the last time in January 2003. Thereafter its role was amalgamated into the Administration Commission. The members had been appraised of the Triennial Review report recommendations and were broadly in favour.

#### Financial:

The financial reports for the year ended 30 September 2002 were reviewed and passed to Council with a recommendation to approve. It was noted that a large donation had enabled a modest surplus instead of the budgeted deficit. The results of the first quarter were examined and a draft forecast budget for the year 2003-2004 was agreed for presentation to Council in February 2003. The Chalice Appeal was discussed and a reception was planned for Associate Members at the GA Annual Meetings 2003. The take-up of the Millennium grant for financial advice to church treasurers and committees had been minimal and this was of concern. The stipend calculation service was growing in popularity.

#### Investments review

The Honorary Treasurer reported on the proposals from Newton Investment Managers to make a radical alteration to our investment portfolio. This had been discussed within the Unitarian Joint Investment Panel in January 2003. This involved the sale of all of our current directly held equity shares and then reinvesting the proceeds in a) approximately six collective funds, specialising in Charity investments and b) moderately increasing the proportion of our investment in fixed income investments. This was felt to be a reasonable course.

#### Staff

Elizabeth Obe became a law degree student in October 2002, but she had been retained as a part-time and temporary employee. The Rev John Clifford advised of his decision to retire from his post as Deputy General Secretary from the end of May 2003. Sarah Tinker had been accepted for ministry training and would leave in September 2003. Consideration was given to the renewal of two officers' employment contracts, due for expiry on September and October 2003. It was agreed that this would be a matter for the new Administration Commission because a rationalised staff plan would be necessary to achieve the financial constraints of the 2003-2004 budget.

#### Closing Thanks:

Finally, the members were thanked for their involvement and contributions to the work of the Committee during a very difficult three years. Special thanks were given to the Rev John Clifford for his secretarial work.





# Income and Expenditure of Unrestricted Funds for the year ended 30 September 2003


# Where our income came from




# How we spent it




# General Assembly of Unitarian and Free Christian Churches Finance and Administration 5 Year Trends






This graph shows monetary grants received. Additionally, the General Assembly receives rent free accommodation from Essex Hall. This year, the value of this accommodation was £95,000.

#### GENERAL PURPOSES COMMITTEE

#### Meetings:

The Committee met in November 2002 and then for the last time in January 2003. Thereafter its role was amalgamated into the Administration Commission. The members had been appraised of the Triennial Review report recommendations and were broadly in favour.

#### GA Annual Meetings 2003:

The Meetings were held at the Riccarton Campus of the Heriot-Watt University, Edinburgh from 13-16 April 2003. The opening devotions were conducted by the Rev Eric Breeze from Aberdeen Unitarian Church. The Anniversary Service was held at St Mark's Unitarian Church, Edinburgh and was conducted by the Rev Jane Barton and the address was delivered by the Rev John Clifford. Jane Aaronson delivered the keynote address on the theme "Unitarians address accessibility issues". The UUA President, the Rev William Sinkford, delivered the Essex Hall Lecture.

The cost of the Heriot-Watt site was significantly higher than originally anticipated and this caused great anxiety to the organisers and resulted in a lower than average attendance. This resulted in a resolution, initiated by the Foy Society, calling for lower cost venues in the future.

#### GA Membership:

The Committee dealt with the application of Durham Fellowship to be accepted as a provisional fellowship member of the General Assembly.

#### Governance:

Close attention was paid to the Home Office consultation document "Private Action, Public Benefit". The Rev John Clifford actively participated in consultation meetings at the Churches Main Committee. The emergence of the Renaissance Group was noted and the constitutional implications of its proposals were noted. It was agreed that the constitutional reforms being worked on by the Rev Steve Dick and Margaret Hamer should not be put to the 2003 Annual Meetings because of the dual impact of

the Triennial Review report and the proposals from the Renaissance Group. The consent agenda concept was discussed.

#### International Matters:

Arrangements were made for our representation at the ICUU meetings in Prague from 28 May – 2 June 2003. The Rev Clifford Reed completed eight years of distinguished service on the ICUU Executive Committee and Christine Hayhurst was elected to this body. The General Secretary also attended.

The IARF Congress of 2002 had ended in some controversy over proposed policy reforms and the Committee heard reports of the subsequent efforts to overcome these problems. IARF Council was served by two GA members, the Rev David Steers and the Rev Johanna Boeke, but neither as direct representatives of the General Assembly.

The Committee maintained all traditional links with our overseas colleagues. The GA President led a party to Transylvania and the General Secretary also visited.

#### General:

Ecumenical and Inter Faith panel reports were received and noted.

#### Last Meeting:

The Committee held its last meeting in October 2002. The Triennial Review proposals had been received by its members and they expressed approval of the amalgamation into the Administration Commission. All present were thanked for their past contributions to the Committee.

#### HYMN BOOK WORKING GROUP

- The New Hymn Book Working Group pays tribute to Sydney Knight (1923-2004) hymn writer and editor of two Unitarian hymns books Songs for Living (1972) and Hymns for Living (1985).
- Having already updated our music software from Sibelius One to Sibelius Two, the group made the decision not to update to the newly issued Sibelius Three.

- During the year we recruited John Clifford to provide us with extra IT know-how. We have also taken on three associates - Michael Dadson, Myrna Michell and Win Simister to help us with the keying in of music.
- 4. We are busy scanning in the words of all hymn texts in the hymns books in current use in British Unitarian churches. We also have on-file the texts of over two hundred hymns which are not in any of our current hymn books. We were able to secure zip disk files of the American Universalist hymn book Singing the Living Tradition and have made ourselves known to the Unitarian Universalist Association's recently appointed new task force charged with producing a supplement to Singing the Living Tradition. At last year's Unitarian General Assembly meetings in Edinburgh we held a hymn singing workshop at which we introduced a selection of new hymns. Our trial CD-Rom of about 50 hymns - texts, pdf music files and midi files - is due out this spring.

#### 1. Grants

The following publicity grants – all towards the cost of notice boards - were made during the year: Taunton £350; Lewisham £300; West Kirby £300; Richmond £200: Newcastle (Staffs) £100.

#### 2. Publications/resources

- a) A new set of wayside pulpit posters went on sale for use on church notice boards.
- b) The Principles That Unite Us, an introductory leaflet about the GA Object, was published.
- c) The Information Officer worked with the Social Responsibility Officer to produce further issues of *Counterpoint*, our outreach newspaper.
- d) The following leaflets were reprinted:

  Unitarian Views of Human Nature and
  Unitarian Wedding Ceremonies A
  Personalised Approach.

#### 3. Advertising and response to enquiries

Advertisements were placed in publications such as *Positive News*, a newspaper on green issues, and *Sesame*, the Open University newspaper. Close to 270 information packs were sent out from the Information Office during the year, mostly in response to these advertisements. The Department also dealt with many other enquiries of a more specific nature, including people seeking to know the location of their nearest church plus requests for help in finding local Unitarian celebrants for personalised wedding, funeral or child naming ceremonies.

#### 4. World Wide Web

The number of congregations with pages in the GA web scheme continued to increase thanks to our team of volunteers. Meanwhile, the GA website was attracting over 17,000 page requests per month.

#### 5. Email Communications

The GA email announcements list was launched in February and is proving a useful and swift means of disseminating news about the General Assembly to those who have opted into the service.

#### 6. Media

The BBC accepted the Information Officer's proposal to feature the Rev Bob Wightman on the Pause for Thought strand of Terry Wogan's show on Radio Two. Dennis Crompton had an article on Unitarianism published in The Guardian's Face to Faith column. A sample press release in the wake of the Canon Jeffrey John affair, presenting the GA stance over gay rights, was circulated by the Department via the UCCN email list. It was picked up by local Unitarians leading to a positive article in the Kendal newspaper, followed by published letters of support.

#### 7. GA Annual Meetings

John Hewerdine was GA Photographer at Sheffield, working alongside Matthew Smith, Press Officer. The Rev Daphne Roberts was in charge of the GA Bookstall, assisted by the Rev Carol Burrows and Peter Bixby.

#### 8. Unitarian Communications Co-ordinators Network

The Information Officer helped to run a successful UCCN weekend conference at Hucklow in November 2002. UCCN is a network for church publicity officers and other interested persons.

#### 9. 2002 Congregational Survey

The number of congregations and fellowship responding to the survey was 134 out of a possible total of 178 – a response rate of 75%. The total

number of GA quota members recorded for the congregations which responded was 3,689. This gives an average quota size per congregation of 27.53. Applying this average size across all congregations and fellowships gives a national quota membership of 4,900 persons. The total number of members recorded for the 134 congregations based on their own definitions of "full membership" was 4,012. The gives an average congregation size, based on local definitions of membership, of 29.94 persons. Applying this average across all congregations and fellowships gives a national figure for "full membership" of 5,329.

#### 10. Structural change

The Information Committee held its final meeting in January 2003 at Essex Hall. Its responsibilities were taken up by the new Outreach and Communication Commission which met for the first time in September 2004.

#### 1. Meetings

The Committee met twice, in October 2002 and January 2003. The Interview Subcommittee also met twice. The Forum for the Co-ordination of Theological Education met once, at Luther King House, Manchester.

#### 2. Roll of Ministers and Lay Pastors

The Rev Donald Phillips was admitted to the Roll in July 2003.

#### 3. Deaths

The Rev Sydney Knight died in January 2004. A former GA President, he will be remembered with great respect and affection.

#### 4. Retirements

Since the last Annual Meetings the Reverends Johanna Boeke, Robin Boyes and Eric Jones and Lay Pastors Vina Curren and Eleanor Dixon have retired. The Committee and Council thank them for their long and dedicated service

#### 5. Training for Ministry

Manchester College and Harris Academy, Oxford Anne Braithwaite completed her third year and undertook student pastorates in the Cotswold Group and with the Enfield and Barnet Fellowship pending the completion of an externally assessed qualification. Donald Phillips completed his studies and was accepted on the GA Roll. Christopher Wilson completed his studies at Oxford in 2003 and continued to complete his degree at Westminster College, Cambridge in the Autumn, some eighteen months in advance of his original schedule. Simon Ramsay (third year) and Linda Phillips (second year) continued their studies. Jane Barraclough commenced her ministry training in September 2003. Cathal Courtney, although registered with UCM, attended at Oxford, by arrangement. The Rev Peter Hewis continued his supervision of the studies of two probationary ministers.

Unitarian College Manchester: Tom McCready, Jean McNeile and Helen Mills, continued into the second year of their studies. Each have undertaken student pastorates as an integral part of their courses. They were joined by Sarah Tinker in the Autumn of 2003. As mentioned above, Cathal Courtney also attended Oxford.

#### Wales

Wyn Thomas continued his studies at Lampeter under the supervision of the Welsh Department.

#### 6. Ministerial Fellowship

Although no goodwill meetings were convened, positive communications were maintained with the Fellowship.

#### 7. Forum for the Co-ordination of Training in Ministry

The eighth meeting took place in May 2003. By the time of this meeting the decisions had been made to form the Ministry Commission. This implied that the role of the forum would be reviewed by that body.

#### Financial Review

The net surplus for the year is £2,786 compared with a budgeted loss of £2,659. Although the trading account shows a deficit of £8,290 donations of £10,858 (including £5,752 from Friends of Hucklow and £2,611 from Open Day) has resulted in a positive outcome for the year. The budget forecasts a surplus for the financial year ending 30th September 2003 of £2,800.

We remain committed to maintaining and improving the fabric of the building and during the year £13,500 has been spent on painting, repairs and improvements. Capital expenditure has also been a major element this year amounting to over £9,000. Items renewed include the central heating boiler, washing machine, cooker, freezer, fridge, photo-copier and fire alarm control panel. Also additional play equipment has been erected and the garden areas to rear of Barleycrofts have been fenced.

Staff wages were increased by 20% in August 2002 to bring them back into line with the going rate for the area. We have successfully managed to absorb this significant increase to our operating costs. Our manager, Liz Shaw, has worked hard to improve income and to tackle the problem of what were unprofitable weekends when one small group had sole use of the building.

Altogether it has been a very busy and expensive year but we have emerged in a strong position to face the challenges of the year ahead despite the disappointment of less Unitarians using the Centre.

#### Development of the Centre

A feasibility study has been undertaken to consider how we can achieve better access for disabled and less mobile elderly guests, more en suite twin bed rooms and an upgraded modern Social Hall facility. The process has now reached a stage where we have a clear view with regard to all aspects of the proposed development. An architect has been appointed to obtain planning

approval and to produce detailed drawings for tendering purposes.

In addition to this proposed major development the Management Committee has an on-going programme of improving the Centre. In the near future we hope to replace the remaining single glazed windows with double glazed units. Unfortunately obtaining planning approval has not been straightforward but negotiations are continuing.

#### Archives

The remaining archives which were stored at the Centre have now been deposited at the Records Office in Matlock. The other known body of archive material is currently held by Geoffrey Head who in the process of writing a history of the Centre. We are always pleased to receive any archive material relating to Nightingale House, Barleycrofts or the Children's Home.

Committee member Freda Laverick has embarked on a project of interviewing those with memories of the 'Homes' in days long past. It is important that we do not lose this oral history. If you have any memories of staying at Hucklow that you would like to share then Freda would be pleased to hear from you.

#### **Unitarian Concessions**

All Unitarians staying at the Centre benefit by a discounted rate. Furthermore we give additional support to Unitarian youth activities based at Hucklow. The self-catering accommodation is still charged at only £5 per person per night (winter rate £4). The Centre also offers the 'Send a Child to Hucklow' charity a special rate for their holidays.

#### www.great-hucklow.org.uk

The web site has received many favourable comments and is proving a useful tool in helping to promote the Centre.

#### Open Day

In June we held our annual Open Day and we are grateful to everyone who contributed to the fun, fellowship and financial success of the day. The amount raised was £2,611.

The Open Day in 2004 will be Saturday 5th June.

Income from Open Day, 'Friends of Hucklow' and other donations remain essential to our financial well-being. If distance prevents you being with us on the day maybe your congregation would consider a local fund raising event in aid of the Centre.

  way of extending the reach of its work it
  maintains contact with individuals within the
  denomination with an interest in, and
  experience of, some aspect of criminal justice
  or penal affairs.
- At the Annual Meetings in 2003 Jean Couper and Tom Murray, respectively Chair of the Scottish Legal Aid Board and Director of Legal Services and Applications, spoke at the Panel's slot about developments in the Scottish Legal Aid system.
- 3. An article entitled "What's wrong with Legal Aid?", written by Bruce Chilton appeared in The Inquirer of 22.3.03. In response to a news item Kate Taylor had a letter published in The Times of 27.9.03, writing as a member of the Penal Affairs Panel. In July 2003 Jane Howarth attended a Day Conference addressed by the Prime Minister, Attorney General and Home Secretary on Community Justice.
- 4. The Panel continues to play an active role in the Churches' Criminal Justice Forum. It was represented at the launch of People, Punishment and Prisons, a report on vulnerable groups of prisoners to which it had contributed. It contributed comments to CCJF's response to the Government's White Paper Justice For All. The Panel has continued to take the lead role in arranging

interfaith meetings on behalf of CCJF, and has worked with members of six faiths to try to develop an Interfaith Criminal Justice Forum.

The Panel is now part of the Outreach and Communications Commission.

The Panel met three times during 2002-3.

During the year we published Unitarian Perspectives on Contemporary Social Issues, edited, like the previous Perspectives volume, by George Chryssides, and Spirit of Time and Place, a collection of prayer-thoughts, praise poems and words of worship by Cliff Reed. Cliff and a number of contributors to the new Perspectives spoke at our well-attended slot at the 2003 General Assembly.

Other projects have remained rather in the testtube than the womb during the year and with some modifications of their genes. They include a possible third volume in the Perspectives series on Contemporary Religious Practice, a companion volume to Celebrating Life with worship material for special occasions, and a book on personal spiritual practice.

We were very sorry to lose Judy Hague during the year.

It must again be stressed that members of the Panel are very active between meetings in undertaking the practical work involved in commissioning essays, reading manuscripts (a number of which were rejected but only after careful assessment and with constructive comments sent to their authors), copy-editing, book design, and dealing with printers.

And, again to repeat a point made in our report last year, it remains disappointing that - apart from the ideas for books generated amongst ourselves - we receive so little worthwhile material of Unitarian interest. We would welcome proposals from able and knowledgeable writers.

# 1. The Religious Education & Youth Department

The period of October 2002 to 2003 was a difficult one for the denomination and an uncertain one for the Religious Education & Youth Department, culminating in the decision to abolish the RE & Youth Officer's post when Sarah Tinker left to commence ministry training. Sarah had worked for the General Assembly for six years and all the committees she had worked with wished her well in this new career move. Elizabeth Obe has continued to work for a day and a half a week at Essex Hall, focussing primarily on bookings, send outs and general enquiries.

#### 1.1 'Safety First' - Code of Practice on Child Protection

A number of queries about child protection issues were handled by the Officer during the year and useful support was received from the Churches Child Protection Advisory Service, an 'umbrella body' that provides expert advice on such matters. Sarah Tinker continues to act as denominational Child Protection Co-ordinator on a voluntary basis and is keen to hear that more congregations have formally adopted a child protection policy in line with Home Office recommendations for voluntary organisations. It is particularly recommended that congregations and groups seek advice from their insurers as having a current child protection policy

is often now recommended, if not insisted upon, by insurance companies. Work progresses on the revised 'Safety First' booklet and a new child protection policy statement has been agreed by GA Council.

#### 1.2 Unitarian Chalice Award Scheme

The Unitarian Chalice Award Scheme is now being used by a number of our children's leaders to provide structure and a sense of progression in the activities they run for young people within congregations. Several leaders have taken the opportunity to write modules of their own and the scheme has now been translated into Welsh. The Officer ran a training session for Sunday School leaders and young people in Lampeter in order to introduce the scheme. The total number of children having received their Bronze Award has now reached thirteen with a great deal of effort on their part and their leaders'. Groups at Bradford Broadway and Urmston have made particularly impressive progress with the Chalice Award Scheme.

#### 2. Religious Education and Lay Training Committees

Following several joint meetings it was decided to seek Council's approval for the amalgamation of the two committees into a new Education & Training Committee, which was approved at Council's February meeting. Such a development was, however, superseded by the decision to create a new structure of Commissions and Panels and the Education & Training Committee was therefore never formed.

#### 2.1 Hucklow Summer School

This re-named Summer School brought a wide variety of participants and leaders together for a week of personal and leadership development. Margaret Hamer proved to be a most stimulating and entertaining theme speaker and the workshops and training sessions were evaluated most positively by those attending. A particular delight of the week was the presence of four babies and toddlers as well as five older children. The presence of children necessitates the provision of high quality childcare, which takes careful planning, but the week's organisers are committed to providing such childcare so that young parents are able to attend a national denominational event. Development Committee members attended the week and ran a workshop on engagement groups. It is hoped that continuing links can be made for joint work on adult education and engagement groups. We are grateful to all the leaders who gave their time freely to work at Summer School

and who waived their expenses claims in order to keep costs down.

Booking forms are now available for this year's Summer School, which is to be held at the Nightingale Centre from the 14 to 21 August. The theme is 'We The Creators' and with Tirrell and Rick Kimball as theme speakers, two highly experienced UUA religious educators, a valuable and thought-provoking week can be expected. The Education & Training Commission would like to encourage all congregations and District Associations to consider sponsoring one of their members to attend Summer School so that they can bring back new ideas for future educational and training possibilities.

2.2 <u>District Religious Education Co-ordinators</u>

Once again, gratitude must be expressed towards our hard-working Religious Education Co-ordinators who in so many different ways encourage the development of activities for

children and adults in their areas

Spiritual Parenting, a short course for parents, grandparents and all those who care for children, is now available and is recommended for use with new as well as established groups. Other courses continue to be used and are available from Essex Hall, especially Building Your Own Theology and Building Our Identity.

# 2.4 The Course in Lay Preaching & The Conduct of Worship (CLPCW)

The CLPCW has a number of active students working on distance learning modules and gratitude must be expressed to the tutors, Revs Baker, Long and Marshall for their continued support for this course and its students. Considerable thanks also go to Dr Don Kerr for all his tireless administrative work over the years. Cyril Haddon's completion of the CLPCW will be recognised at the Annual Meetings and congratulations go to him for this achievement.

#### 3. Youth Committee

The Youth Committee met twice during the year for the continuation and development of the NYP, to further the cause of the Youth Officer position, actively lobby GA Council on all issues relating to youth and contribute to the discussion on the future structure of GA Committees.

#### 3.1 National Youth Programme

The Youth Committee is responsible for a programme of events which are organised for young people, at present mostly at Great

Hucklow, for three different age groups: Juniors (7-11), Inters (11-14) and Seniors (14-18). These have all been well subscribed with a pleasing increase in the numbers attending Senior Weekends. As always our grateful thanks go to the loyal and hardworking leaders of all these events, who generously give their time and energy to ensure that young Unitarians & Free Christians have a unique experience of being together. Our dedicated Jeaders make our National Youth Programme (NYP) possible. Particular thanks go to Norman and Sylvia Elthorpe who have been leading Inter Weekends for so many years with quiet reliability and good humour.

It is noticeable that congregations which regularly send young people to NYP events often put considerable effort in to this, perhaps by offering subsidies, by making sure that young families get information about NYP events or by providing help with transport. We would like to convey special thanks to the individuals and congregations who do support the youth programme in this way and who are committed to sharing their liberal faith with the next generations.

The Youth Committee would also like to convey its on-going thanks to the Management Committee and staff of the Nightingale Centre for continuing to be so supportive of our youth programme and for giving such positive and practical assistance.

#### 3.2 Bridging Weekend

In March the first Bridging Weekend was held for 12 to 13 year olds. With twenty young people attending, the weekend succeeded in its aim of encouraging young people to remain involved with the Youth Programme in their teenage years. It was very pleasing to note that sixteen of these youngsters then chose to attend the next Inter Weekend. Two more annual Bridging Weekends will be held and the Committee is grateful for financial support from the Millennium Fund to make this positive development possible.

#### 3.3 YUC Week

YUC Week 2003's theme was 'You'll Never Walk Alone', which led into a wide range of activities, both spiritual and more material! The week was thoroughly enjoyed by all concerned and many of the young people continue to keep in touch with one another. YUC Week 2004 will take place from 1st to 7th August with a theme of 'What A Wonderful World'

#### 3.4 YUC & Seniors Re-Union Weekend

A YUC Week and Seniors Re-union Weekend was held at Hucklow in July alongside the regular Senior Weekend. It gave past participants the chance to meet up with one another and to enjoy reminiscing over old photographs. Thirty-six young people spent a highly entertaining weekend together with old friendships being renewed and new links being made.

#### 3.5 18+ Group

The 18+ group have spent two successful weekends together at Flagg and Great Hucklow during the year, on the themes of Spirituality (led by Rev Simon John Barlow) and Leadership (led by Rev Bob Wightman), and enjoying the Derbyshire countryside. It is pleasing to report that every 18+ Weekend has had at least one new person attending, often people who are new to national events of this kind.

#### 3.6 18-35 Weekend

A residential weekend for 18 to 35 year olds was once again held at Hucklow in the spring and brought together an interesting mixture of old and new faces.

#### 3.7 Proposed Youth Officer Post

The decision not to re-appoint an RE & Youth Officer when the current Officer left has meant that the National Youth Programme is being run entirely by volunteers and without a trained contact person available out of hours. This has made the Youth Committee's project to appoint a Youth Officer entirely dedicated to this work all the more urgent.

#### OFFICE OF SOCIAL RESPONSIBILITY

1. Meetings: The Committee met only once during the financial year 2002-2003. A second meeting had been planned for May 2003, but this was cancelled due to budgetary constraints.

#### 2. Denominational Activities

SR Survey: In 2003, a pilot survey on present day social responsibility action by both congregations and individual Unitarians was carried out in NELUM (North East Lancashire Unitarian Mission). Tony Rees, SR Panel member and a professional sociologist, analysed the returns (55%) and produced a report, which resulted in some amendments to the questionnaire and this will be sent out nationwide during January 2004. One aim of this survey is that it should give direction to the SR function at national level, thus helping to plan future work.

GA Theme 2003-05 "Removing Barriers: Unitarians address disability issues": Several SR activities have been linked to this new GA theme, such as the running of a workshop, specially concerned with mental health, at the 2003 Annual Meetings, and the production of a resource pack focusing on disabilities more generally.

Counterpoint: We produced two issues (Spring & Autumn 2003) of this occasional newspaper with the assistance from the Information Officer. We continue to receive positive feedback from those who receive a copy; especially first time enquirers and MPs. Thirty congregations have requested extra copies for distribution at local level. We have funding for two further issues during 2004, and are seeking support from outside Trusts to enable us to offer this publication in future years. The quarterly SR Newsletter and SR columns in The Inquirer also continued to appear during the year.

Social Responsibility at local level: As in previous years, many congregations and fellowships were actively involved in social

justice action through marking such occasions as Homelessness Sunday and Peace Vigil weekend; and by supporting campaigns like Debt on our Doorstep; 'Stop the War' and Water for Life

Unitarian congregations and individuals have also been spurred on by General Assembly Resolutions to support efforts by Oxfam, Amnesty International and others, aimed at securing a new International Arms Trade Treaty to stop the flow of arms to potentially abusive regimes; and to respond generously to the special appeal for the life saving work in Iraq by Save the Children.

The work of the SR Officer has included involvement in denominational events at local. district, national and international levels. She has given talks. led workshops and seminars on social justice work in general and on specific contemporary issues and causes. She attended 'Unitariertag 2003', the biennial meetings of the German Unitarian Fellowship; talked about SR work to members of the LDPA Lav leaders' Forum, and led services at congregations and fellowships around the country.

SR Network: We continue with our efforts to expand the denominational SR network by offering to facilitate workshops and seminars on contemporary social justice; by offering our support to existing SR committees and working groups as and when necessary; and by trying to identify those individuals who have time and energy to support our work.

- 3. Ecumenical Activities: We offered our support to and attended meetings of the following ecumenical agencies: Christian Aid: CTBI Church & Society Forum; CTBI Racial Justice Network; Churches World Development Network (CWDN): Church Action on Poverty (CAP); Church Action on Disability (CHAD); Network of Christian Peace Organisations (NCPO); and One World Week (OWW). Dawn Buckle (GA Vice-President), attended the June 2003 CTBI Church & Society meetings in Manchester on our behalf. Our contribution to ecumenism in offering a costfree venue for meetings at Essex Hall has continued. We have promoted and shared in campaigns organised by CAP, Christian Aid, CAFOD, Churches National Housing Coalition, and Trade Justice Movement
- 4. Secular Activities: The Officer of Social Responsibility has worked closely - attending meetings, being represented on committees where appropriate - with a wide range of non-religious organisations: Amnesty International: Campaign Against the Arms Trade; Campaign for Nuclear Disarmament: Development Education

Association; Friends of the Earth; Greenpeace; Liberty; National Assembly Against Racism; New Economic Foundation: United Nations Association UK; UNICEF; WaterAid; World Development Movement; Womenkind Worldwide, and others.

- Voluntary Work: Rosemary Ruston continues to work one day a week for the Office of Social Responsibility on a voluntary basis, and we would like to thank Rosemary for the valuable contribution she has made
- 6. The Impact of the Triennial Review Working Party's (TRWP): The implementation of the radical reorganisation of the General Assembly' structures proposed by the TRWP has affected the Office of Social Responsibility considerably, together with the financial stringency which, in good measure, brought the recommendation about. The SR Committee has been succeeded by a smaller SR Panel, reporting to the new Outreach & Communication Commission. The title of SR Officer has been changed to SR Coordinator. She has been allocated important responsibilities in other GA activity, and the resources available for SR work have accordingly diminished. However, the firm intention is to continue to work on the basis of the SR "Mission Statement", raising awareness about contemporary social justice issues, and increasing participation in social justice work in order to strengthen our social witness in society.

Sexual Orientation Equality Group Members: Rev Jeff Gould, Linda Phillips, Sarah Tinker, and Rev Charles VanDenBroeder.

In keeping with the remit of the Resolution passed at the Annual Meetings in 2000, the Sexual Orientation Equality Group completed its work at the Annual Meetings 2003. Group members were pleased with the positive response received at the launch of 'Celebrating Diversity', a resource pack on sexual orientation and other equality issues. These eye-catching pink folders have been bought by congregations and groups around the country and copies are still available. It is pleasing to report that a number of copies have been sold outside the denomination and that positive feedback has been received from those using it. The pack contains a wealth of worship material, as well as a wide range of workshop activities suitable for use in various settings, and is recommended to all.

A survey has been made of congregations and worship leaders to ascertain the availability of celebrants and possible venues for the celebration of same sex union blessings. It has yet to be decided how best to make this information available within the denomination.

During SOEG's three years of existence the pace of legislative reform in the sphere of sexual orientation has accelerated and our hope is that the group's work will help congregations to reflect the changes now taking place in UK society.

Objects of the Fund

The objects of the Fund shall be to aid in the maintenance of faithful and efficient Ministers serving congregations affiliated to the General Assembly of Unitarian and Free Christian Churches.

#### The Committee

The Trustees are appointed by the Council of the General Assembly of Unitarian and Free Christian Churches on a triennial basis, to manage the trust as a Departmental Committee of the General Assembly. The Custodian Trustee is the British and Foreign Unitarian Association (Incorporated).

#### Administration of Grants

Application forms for grants are available from the Secretary via the District Associations. The Trustees meet in June or July each year to consider applications for grants for the year commencing the first of October following. The grants are then paid in quarterly instalments.

The Trustees met once during the year on 15 July. The Officers administering the grants maintained a close liaison amongst themselves throughout the year.

#### 5. **Annual Accounts**

The Accounts for the year ended 30 September 2003 showed an operating deficit of £954 (2002:£7,966). After a net investment gain from disposals of £21,981 (2002:£40) and a year end market revaluation gain of £2,559 (2002:£68,487 Loss), there was an overall surplus of £21,946 (2002: £78,418) for the year. The gain on the investments was due to a very welcome recovery in the stock market.

#### Investments

Newton Investment Management Ltd, 71 Queen Victoria Street, London, EC4V 4DR, continued as Investment Managers. The investments are held in the name of the Custodian Company of the Bank of New York, 1 Canada Square, London E14 5AL, on behalf of the Trustees, and may be held outside the United Kingdom. The investment policy is to maximise the total return from a portfolio managed to produce a balance between income and growth. It may be necessary from time to time to supplement income by withdrawals from Capital growth. The portfolio was completely reorganised during the year into a smaller number of larger holdings. They were valued as at 30 September 2003, by Newton Investment Management Ltd.

#### 7. Grants

Applications for grant-aid towards the payment of stipends were received for the support of 24 Ministries, of which 2 were new applications. Of these 24 applications, 2 were refused. Of the 22 awards made 15 ceased part way through the year Pig due to the Ministers moving elsewhere or retiring. It has always been a condition of the payment of the grants, that the recipient should have paid the General Assembly Quota in respect both of the previous year and of the year during which the



Grant is paid. Following the decision of the General Assembly Council that each Congregation should pay its Quota by no later than 31 December each year, it has been further decided that the Grants shall be withheld from any Congregation whose Quota is still unpaid by the following 31 March, and not reinstated until it had paid its share of the quota.

# FUND FOR LAY PASTORS AND APPROVED LAY LEADERS

- Four applications for grant aid were received and a grant was awarded to each applicant.
- 2. Although coming after the year end, acknowledgement must be made of the generous gift by the members of UALL of the remaining funds of the Unitarian Lay Preachers Association on merger of that association with UALL. The amount of £868.74 is a welcome addition to the capital of the Fund and members of UALL and the Lay Preachers Association are thanked for their generosity. The Secretary of the Sustentiation Fund was invited to receive the cheque at the Annual Meeting of UALL at Great Hucklow in November 2003.

Such contributions to the capital of the Fund are always welcome as the income thus generated enables more or larger grants to be given.

#### Y GYFADRAN UNDODAIDD UNITARIAN WELSH DEPARTMENT

The membership has been cut from 12 to 8 members.

Two meetings were held during the year.

 DAY CONFERENCE: A meeting at Tabernacle Chapel, Carmarthen was arranged on June 21<sup>st</sup> with the aim of setting up a

- network whereby groups of Congregations could come together to discuss Unitarian ethos and its significance within today's Society. This would be the beginning of a series of meetings covering a smaller geographical area. Wyn Thomas and Rev Paul Overend addressed the meeting with around 40 people present and their addresses were a challenge to the Unitarian Congregations of the future. A copy of the addresses was sent to each congregation with a request that they arrange a discussion of the papers at a local level. Some congregations did respond to the request but not all by any means.
- 2. PRESIDENT'S VISITS: Alan Ruston attended the retirement Dinner arranged for the Rev Eric Jones on 22 February 2003 when he brought the greetings and appreciation of the General Assembly for the occasion. Rev Eric Jones retired after serving the congregation at Aberdare for over 40 years before adding on the Cardiff Congregation in 1970 and the Cefncoed Congregation in 1999. He has also been the Secretary of the Welsh Department since 1964. The President made a visit to Cwmsychbant in West Wales at a later date. Rev Austin Fitzpatrick visited Swansea and West Wales in September and brought the greetings of the Assembly to members of both the Welsh Districts.
- 3. UNITARIAN EISTEDDFOD TENT: Arrangements are in hand for a Unitarian presence at the Newport National Eisteddfod in August 2004. Plans include a series of interest areas which Unitarians can provide including Inter Faith, Earth Spirit, Same Sex Blessings and other areas which we hope could give us an identity which would differ from the other Churches on the field. Tea and a rest area would also be included.
- 4. PUBLICATIONS: A New Version of the Welsh Unitarian Handbook was produced during the year and distributed among various Groups in Wales so that contact with the denomination is easily made when needed. Rev Eric Jones is also in the process of producing a Booklet which will identify some Unitarian sites in Wales which are in danger of being forgotten. It will include a picture (where this is possible), a brief background history and a map reference as to how to find the site. It will be some kind of Heritage Trail for those who are interested in making visits to such places.

- 5. FUTURE OF THE DEPARTMENT:
  Lengthy discussions regarding the future role
  of the Department have taken place. Some
  activities have been transferred to the District
  Associations and other activities, we felt,
  needed to be taken closer to the
  Congregations whilst both Districts are
  encouraged to arrange joint social events
  which would bring the people together whilst
  not adding to the cost of the Department. The
  cost of the National Eisteddfod tent is very
  high and digs deep into a small and reduced
  budget but it was felt that it was of benefit and
  some way of helping with the cost is being
  sought.
- 6. STUDENT: Wyn Thomas, a student training for the Unitarian Ministry, has been successful in his college examination to end his second year of study at Lampeter. He takes services very acceptably and should complete his degree in June 2004. The following year will be taken up with training in Pastoral work with some residential visits to both UCM and HMCO as well as some internal short courses in Wales.
- 7. REPORTS: We are now receiving substantial reports from both Districts and from Council at every meeting and consider whether the Department is able to do anything to strengthen some of the activities in both areas and to help with difficult or weak situations.

#### WORSHIP COMMITTEE

- Small numbers, great distances and a small budget have made meeting arrangements difficult for this committee/panel. The occasional telephone conference still leaves us working within tight constraints.
- Notwithstanding this difficulty, the group has worked hard to stimulate growth in the quality of worship in our movement through example, ideas and materials.
- Following A Fair Field Full of Folk and Green and Dying, the meditation manual Waiting to

- be Discovered was launched at the 2003 Annual Meetings in Edinburgh. Compiled by Joy Croft and Jopie Boeke, with prayers, prose and poetry mainly by previously unpublished writers, it comprises seven sections: Discovering Nature, Discovering God, Discovering Self, Discovering Choice, Discovering Hope, Discovering Meaning and Discovering Community. At eight pounds, it is an excellent resource for public and private worship. Earlier Worship publications, including Shores of Darkness by Rosemary Arthur, the only worship material specifically for evening worship, have been advertised in many Unitarian newsletters and magazines.
- 4. The Worship Committee was responsible for almost all the worship at the Edinburgh Annual Meetings. Margaret Hill's Quiet Room on the theme of trees was both stunning and restful. The morning worship services led by Lorna Hill and David Monk were uplifting and challenging. Alex Bradley with Alan Kennedy provided stillness and hope in the Communion Service. The pre-Business meditations, led by Lindy Latham, Rosemary Ruston and Peter Godfrey, all helped us to focus on the theme of inclusion. In the Worship Workshop, well attended as ever, Brian Anderson and Dawn Buckle led us in an exploration of the theme of Quiet Works.
- 5. Members of the Committee/Panel have contributed regular columns to The Inquirer, exploring the nature of worship and its possibilities and including from time to time prayers and poems which might be used in public or private worship. The current panel is seeking to elicit, through The Inquirer, ideas for new ways of worshipping, which might be gathered in a future publication.

#### ADMINISTRATION COMMISSION

Chair: Jennifer Atkinson

Members: Dawn Buckle, Rev Steve Dick, Robert Fincham, the GA President, Immediate Past-President, General Secretary and Honorary Treasurer.

The establishment of the Administration Commission was approved by Council in February 2003 as a result of the Triennial Review report. It replaced the Executive, Finance & Administration and General Purpose committees. Two minor exceptions were the transfer of accountability of the Ecumenical and Inter Faith Panels to the Outreach and Communication Commission. The members were appointed at the Triennial Council meeting held in Edinburgh at the close of the Annual Meetings.

The first meeting took place on 1 May and the second on 23 June. Both meetings were faced with busy agendas that combined long-term considerations with current decision-making necessities. Preliminary consideration was given to the terms of reference and mission statement. The tasks to be done were prioritised.

Immediate priorities included: a) the completion of arrangements for the establishment of the Commission structure and the election, by Council, of members of the Commissions and Panels; b) the finalisation of the budget proposals for 2003-2004; c) the arrangements to create the Task Force; and d) the establishment of the Annual Meetings review working party, as required by a resolution from the Annual Meetings.

A critical aspect of the budget exercise was the review and approval of the staff plan. This involved a 30% reduction in the staff establishment and two Commission members were detailed to consult staff and report back to the June meeting.

The preparations for the establishment of the remaining Commissions and the establishment of the Task Force came to fruition at the July Council meeting. The Annual Meetings working party was quickly established with Andrew Mason as its co-ordinator and it was able to report to the November Council meeting.

The Commission was budgeted to meet four times per annum to coincide with quarterly financial results. In between meetings urgent matters of decision were progressed by email networking.

As the financial year closed, the Commission was planning a residential meeting to finalise its mission statement and commence the task of developing its objectives and strategic thinking

#### Risk Management

The Trustees (Council) have continued to review and monitor the major risks facing the charity. The Trustees have then undertaken appropriate measures to counter the identified risks. The reorganisation flowing from the Triennial Review is an example of such action. This has incorporated a greater focus upon strategic planning. Risk analysis is an integral part of strategic planning. It is anticipated that this will result in more highly developed risk management.

### The New Commission Structure

The Triennial Review Working Party of 2002 recommended a considerable rationalisation of the General Assembly's committees, not only for the sake of economy, but also because it needed more effective structures and a more strategic approach to its activities. The Triennial Review report was first received by Council in November 2002 and then in more detailed form in February 2003.

The core of the recommendations was the creation of four Commissions to enable the specialist planning, operation and control of the General Assembly's functions. With certain exceptions, the committees would either be absorbed into the Commissions, or would become panels, responsible to them.

The Administration Commission, which was an amalgamation of the Executive, Finance & Administration and General Purposes committees, was approved by Council in February 2003 and its membership was appointed in April 2003. Its activities are reported elsewhere within this report.

The report had originally recommended the creation of three other Commissions:

Denominational Support Education & Training Outreach & Communication

A debate arose about the absence of a separate Commission for Ministry. The February Council decided not to make a final decision and, instead, refer the matter for discussion at the 2003 Annual Meetings. These meetings duly debated the whole issue and passed a resolution to include a Ministry Commission, as well as giving a clear mandate to Council to go ahead with the remaining proposals.

The final arrangements, including the appointment of personnel to the Commissions and panels, was dealt with by Council in July 2003. The four new Commissions commenced their activities during the Autumn of 2003 and their activities will be reported in the 2004 Annual Report ready for

the 2005 Annual Meetings. In each case the Commissions are commencing their roles with the development of mission statements and objectives within agreed terms of reference.

The chief functions of the Commissions are as follows:

#### Administration

Strategic planning.
Control of the Unitarian Headquarters.

Financial planning and control, including forecasting, budgeting, investment, fund raising, accountancy and statutory compliance.

Legal and governance matters.
Organising the Annual Meetings.
International relationships.
Liaison with the Nightingale Centre.

#### **Denominational Support**

Development and support services to congregations, fellowships and district associations.

Associated panels and working parties:

Buildings Advisory, Congregational
Consultancy, Engagement Groups, Worship
and Youth.

#### **Education & Training**

Adult religious education.

Training courses and resources for lay persons and ministers
Operation of the Course for Lay Preaching and the Conduct of Worship.

#### Minister

Maintenance of the GA Roll of Ministers and Lay Pastors.

Maintenance of the GA Roll of Lay Leaders. The recruitment, selection and training of ministers, lay pastors and lay leaders.

Associated panels and working parties: Interview, Review & Support, Forum for the Co-ordination of Training for Ministry.

#### **Outreach & Communication**

The communication of information and our message to external individuals and the media.

The publication, sales and distribution of contemporary Unitarian writings.

The development of our relationships with other faiths and religions.

The development of our social witness.

Associated panels and working parties:
Ecumenical, Interfaith, Penal Affairs,
Publications and Social Responsibility.

#### THE TASK FORCE

Following a campaign by the Renaissance Group, the following Resolution was passed at the 2003 Annual Meetings:

"That this General Assembly of Unitarian and Free Christian Churches instructs GA Council to appoint a task force to develop proposals to change the system of governance to have a nationally elected leadership, and to present them at the 2004 General Assembly."

GA Officers met with the Bowland Charitable Trust who kindly agreed to fund the Task Force. The Administration Commission then appointed an independent team of three experienced Unitarians to interview and select a well-qualified consultant to organise and facilitate the Task Force. The team also sifted through the application forms from volunteers. Their recommendations were accepted by the GA Council in July 2003.

Colin Fisher of the Christopher Street Organisation was appointed as the Consultant.

The Task Force members are:

Marion Baker, Dawn Buckle, Tony Cann, the Rev John Clifford, the Rev Michael Dadson, Jeffrey Davies, the Rev Steve Dick, Dorothy Hewerdine, John Lawrence, Andrew Phillips, Louise Rogers, the Rev David Usher.

During August 2003 Colin Fisher visited all of the Task Force members prior to their first meeting. Since September 2003 the Task Force members have met many times as a full

team and in smaller groups and have maintained a busy email contact with each other. The report is due to be presented at the Annual Meetings 2004.



### The General Assembly of Unitarian and Free Christian Churches

#### Trustees' Responsibilities In Relation To The Financial Statements

# INDEPENDENT AUDITORS' REPORT TO THE TRUSTEES OF THE GENERAL ASSEMBLY OF UNITARIAN AND FREE CHRISTIAN CHURCHES

We have audited the financial statements of the General Assembly of Unitarian and Free Christian Churches for the year ended 30 September 2003, which comprise the Statement of Financial Activities, the Balance Sheet and related notes. These financial statements have been prepared under the historical cost convention as modified by the revaluation of certain fixed assets and the accounting policies set out therein.

This report is made solely to the General Assembly of Unitarian and Free Christian Churches members, as a body. Our audit has been undertaken so that we might state to the charity's members those matters we are required to state to them in an auditor's report and for no other purpose. To the fullest extent permitted by law, we do not accept or assume responsibility to anyone other than the charity and the charity's members as a body, for our audit work, for this report, or for the opinions we have formed.

#### Respective Responsibilities of Trustees and Auditors

The trustees' responsibilities for preparing the Trustees' Annual Report and the financial statements in accordance with applicable law and United Kingdom Accounting Standards are set out in the Statement of Trustees' Responsibilities.

We have been appointed as auditors under section 43 of the Charities Act 1993 and report in accordance with regulations made under section 44 of that Act. Our responsibility is to audit the financial statements in accordance with relevant legal and regulatory requirements and United Kingdom Auditing Standards.

We report to you our opinion as to whether the financial statements give a true and fair view and are properly prepared in accordance with the Charities Act 1993. We also report to you if, in our opinion, the Trustees' Annual Report is not consistent with the financial statements, if the charity has not kept proper accounting records, or if we have not received all the information and explanations we require for our audit.

We read other information contained in the Trustees' Annual Report, and consider whether it is consistent with the audited financial statements. We consider the implications for our report if we become aware of any apparent misstatements or material inconsistencies with the financial statements. Our responsibilities do not extend to any other information.

#### Basis of Audit Opinion

We conducted our audit in accordance with United Kingdom Auditing Standards issued by the Auditing Practices Board. An audit includes examination on a test basis, of evidence relevant to the amounts and disclosures in the financial statements. It also includes an assessment of the significant estimates and judgments made by the trustees in the preparation of the financial statements, and of whether the accounting policies are appropriate to the General Assembly's circumstances, consistently applied and adequately disclosed.

We planned and performed our audit so as to obtain all the information and explanations which we considered necessary in order to provide us with sufficient evidence to give reasonable assurance that the financial statements are free from material misstatement, whether caused by fraud or other irregularity or error. In forming our opinion we also evaluated the overall adequacy of the presentation of the information in the financial statements.

#### Opinion

In our opinion the financial statements give a true and fair view of the state of affairs of the General Assembly of Unitarian and Free Christian Churches as at 30 September 2003 and of its incoming resources and application of resources in the year then ended and have been properly prepared in accordance with the Charittes Act 1993.

#### The General Assembly of Unitarian and Free Christian Churches

#### Notes to the Accounts for the Year Ended 30 September 2003

#### Accounting Policies

The financial statements have been prepared under the historical cost convention, as modified by the inclusion of investments at market value and in accordance with applicable accounting standards. In preparing the financial statements the General Assembly follows best practice as set out in the Statement of Recommended Practice 'Accounting and Reporting by Charities' (SORP) issued in October 2000 and the Charities Act 1993. The principal accounting policies adopted in the preparation of the financial statements are as follows:

#### a. Donations, legacies and gifts

Donations, legacies and gifts are included in the year in which they are receivable, which is when the General Assembly becomes entitled to the resource.

#### b. Investment income

Income from investments is accounted for in the period in which the General Assembly becomes entitled to the receipt.

#### c. Resources expended

All expenditure is included on an accruals basis. A detailed analysis of expenditure and allocation between funds is detailed in notes 8 to 11 to the financial statements. Grant expenditure is detailed in note 2 to the financial statements.

#### d. Staff salary costs

Approximately 50% of full time equivalent staff hours are spent on programme work. Accordingly, total salary costs have been split equally between programme support costs and management and administration costs.

#### e. Funds accounting

Funds held by the General Assembly are:

Unrestricted general funds – these are funds which can be used in accordance with the charitable objects at the discretion of the trustees.

Designated funds – these are funds set aside by the trustees out of unrestricted general funds for specific future purposes or projects.

Restricted funds – these are funds that can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Endowment funds – permanent and expendable endowment funds are the result of gifts to the charity that are to be invested and the income thereof used for the purposes of the charity either as restricted or unrestricted funds dependant on the wishes of the donor.

Further details relating to each fund is included in the notes to the accounts.

#### f. Fixed asset investments

Investments are included at closing mid-market value at the Balance Sheet date. Anygain or loss on revaluation is taken to the Statement of Financial Activities.

#### g. Tangible fixed assets and depreciation

Freehold land and property held jointly are not depreciated. The cost of equipment is written-off by equal annual installments over their expected useful lives as follows:

Furniture 5 years
Computer Equipment 3 years

#### h. Stock

Stocks are valued at the lower of cost and net realizable value.

#### i. Pensions

The General Assembly operates a defined contribution scheme available to all eligible employees. The assets of the scheme are held separately from those of the charity in independently administered funds. Pension costs charged in the Statement of Financial Activities represent the contributions payable by the General Assembly in the year.

#### 2 Direct Charitable Expenditure - Grants

During the year to 30 September 2003, the General Assembly has made grants to enable the promotion of a free and inquiring religion in the UK and abroad, and for the education of ministers of religion and the relief of poverty. See also note 4 for details of grants made between unrestricted, designated and restricted funds of the General Assembly.



#### Notes to the Financial Statements - 30th September 2003

- The Land and Buildings comprised in the Charities called The Unitarian Convalescent and Holiday Centre are vested in the British and Foreign Unitarian Association (Incorporated) as Custodian Trustee. The Convalescent and Holiday Centre was valued at 30th September 1999 for insurance purposes at £1,265,000 and the Barleycroft Building was valued at 30th September 1999 for insurance purposes at £400,000. For the purpose of capitalising the Land and Buildings the value of the Net Building Improvements amounting to £253,353 at 30th September 1999 has been deducted from the valuation to arrive at a net valuation of the Land and Buildings of £1,411,647.
- Income received from Appeal funds is not reflected within the Income and Expenditure Account but taken directly to the Fund to which it relates.

  When Appeal Funds are closed they are transferred to the Capital Account.

#### 3 Accounting Policy

Building improvement works are capitalised.

#### 4 Depreciation Policy

Maximum forty years for building improvements and twenty five years for furniture and equipment.

Freehold Property is not depreciated as, in the opinion of the Committee, the property is not worth less than its book value and, therefore, any depreciation would be immaterial.

#### 5 Investments

The investments consist of 25 Charifund Accumulation Units and 13.16 COIF Charities Investment Fund Units.

The Trustees are obliged to prepare financial statements for each financial year.

The financial statements must give a true and fair view of the state of affairs of the Centre at the end of the financial year and of the excess of receipts over payments for the year. The Trustees are responsible for the adoption of suitable accounting policies, and their consistent use in the financial statements, supported where necessary by reasonable and prudent judgement.

The Trustees confirm that the above requirements have been complied with in the financial statements.

In addition, the Trustees are responsible for maintaining adequate accounting records and sufficient internal controls to safeguard the assets of the Centre and to prevent and detect fraud or any other irregularities. It is also responsible for a programme of risk assessment. This is a continuous exercise.

The Trustees have examined the major strategies, business and operational risks which the Charity faces and confirm that the systems have been established to enable regular reports to be produced so that the necessary steps can be taken to lessen these risks.

It is the policy of the charity to maintain unrestricted funds, which are the free reserves of the charity, at a level which equates to approximately one year's unrestricted expenditure. This provides sufficient funds to cover management and administration and support costs and to respond to emergency maintenance costs which arise from time to time. Unrestricted funds were maintained at this level throughout the year.

### Report of the Trustees

#### 1. Objects of the Fund

The objects of the Fund shall be to aid in the maintenance of faithful and efficient Ministers serving congregations affiliated to the General Assembly of Unitarian and Free Christian Churches.

#### 2. The Committee

The Trustees are appointed by the Council of the General Assembly of Unitarian and Free Christian Churches on a triennial basis, to manage the trust as a Departmental Committee of the General Assembly. The Custodian Trustee is the British & Foreign Unitarian Association (Incorporated).

#### 3. Administration of Grants

Application forms for grants are available from the Secretary via the District Associations. The Trustees meet in June or July each year to consider applications for grants for the year commencing the first of October following. The grants are then paid in quarterly instalments.

#### 4. Meetings

The Trustees met once during the year on 15th July. The Officers administering the grants maintained a close liaison amongst themselves throughout the year.

#### 5. Annual Accounts

The Accounts for the year ended 30th September, 2003, showed an operating deficit of £954 (2002:£7,966). After a net investment gain from disposals of £21,981 (2002:£40) and a year end market revaluation gain of £2,559 (2002:£68,487 Loss), there was an overall surplus of £21,946 (2002:£78,418) for the year. The gain on the investments was due a very welcome recovery in the stock market.

#### 6. Investments

Newton Investment Management Ltd, 71, Queen Victoria Street, London EC4V 4DR, continued as Investment Managers. The investments are held in the name of the Custodian Company of the Bank of New York, 1, Canada Square, London E14 5AL, on behalf of the Trustees, and may be held outside the United Kingdom. The investment policy is to maximise the total return from a portfolio managed to produce a balance between income and growth. It may be necessary from time to time, to supplement income by withdrawals from Capital growth. The portfolio was completely reorganised during the year into a smaller number of larger holdings. The investments were valued as at 30th September, 2003, by Newton Investment Management Ltd.,

#### 7. Grants

Applications for grant-aid towards the payment of stipends were received for the support of 24 Ministries, of which 2 were new applications. Of these 24 applications, 2 were refused. Of the 22 awards made, 5 ceased part way through the year due to the Ministers moving elsewhere or retiring.

It has always been a condition of the payment of the grants, that the recipient should have paid the General Assembly Quota in respect both of the previous year and of the year during which the Grant is paid. Following the decision of the General Assembly Council that each Congregation should pay its Quota by no later than 31st December each year, it has been further decided that the Grants shall be withheld from any Congregation whose Quota is still unpaid by the following 31st March, and not reinstated until it had paid its share of the Quota.

Note 2 For greater ease of reading, the figures in these Accounts are shown in round pounds. In places, this may suggest that they do not "add-up". This is due solely to the rounding. There are no discrepancies in the Books of Account.

#### RESPONSIBILITIES OF THE TRUSTEES
