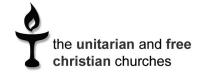

#### **General Assembly President's Report**

## General Assembly President 2011-2012 Rev Dr Ann Peart

During my year it has been my privilege to visit a huge variety of congregations and groups which are associated with the General Assembly. At the time of writing there are over two months of my presidential year to run, so some highlights, such as my visits to the Dublin Congregation and the Non-Subscribing Presbyterian Church of Ireland have yet to take place. By the end of my term of office I expect to have visited about 70 congregations, all except one of the district associations in England, Scotland and Wales, and various other groups, including the Unitarian Christian Association, the Unitarian Renewal Group, the Women's League, The Women's Group, the Foy Society, Send a Child to Hucklow, The Nightingale Centre, the Widows' Fund, the Hibbert Trust.

It was a particular privilege to give out certificates to nine people from England and Wales who completed the REvolution course which trains people to "lead spiritual explorers" as leaders of religious education with children and young people.

Other General Assembly initiatives in which I, as President, have been involved include the Sustentation Fund, Stipend Review Committee and Unitarian Communications Coordinators' Network. I attended the valedictory services and annual meetings of both Harris Manchester College and Unitarian College Manchester, and several induction services for newly appointed ministers and lay pastors. Contrasted with these were funerals of ministers and lay people who have served the movement at national level.

I have represented the movement at several interfaith meetings, the annual Remembrance Service in Whitehall and the Gay Pride parade in Manchester.

At district meetings and in leading congregational worship I have talked of our tradition of changing both our beliefs and our practice in the light of new knowledge and deeper experience, and of the diversity of belief and practice from the very outset of our national movement, leading to the need to practice the art of treating each other well as we balance both individuality and community.

My thanks go to the many people who have so graciously given me hospitality and transport and shown me significant Unitarian historical sites. It has been a delight and a privilege to serve the movement as its President.

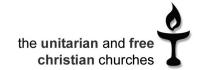

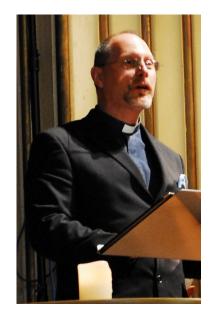

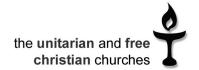

#### The Object of the Assembly

From the Constitution of the General Assembly as amended 19 April 2001 and approved by the Charity Commission and further amended 27 March 2008:

#### 2. Object

#### Preamble

We, the constituent congregations, affiliated societies and individual members, uniting in a spirit of mutual sympathy, co-operation, tolerance and respect; and recognising the worth and dignity of all people and their freedom to believe as their consciences dictate; and believing that truth is best served where the mind and conscience are free, acknowledge that the Object of the Assembly is:

#### Object

To promote a free and inquiring religion through the worship of God and the celebration of life; the service of humanity and respect for all creation; and the upholding of the liberal Christian tradition.

To this end, the Assembly may:

Encourage and unite in fellowship bodies which uphold the religious liberty of their members, unconstrained by the imposition of creeds;

Affirm the liberal religious heritage and learn from the spiritual, cultural and intellectual insights of all humanity;

Act where necessary as the successor to the British and Foreign Unitarian Association and National Conference of Unitarian, Liberal Christian, Free Christian, Presbyterian and other Non-Subscribing or Kindred Congregations, being faithful to the spirit of their work and principles (see appendix to the constitution), providing always that this shall in no way limit the complete doctrinal freedom of the constituent churches and members of the Assembly;

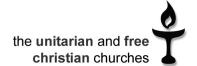
Do all other such lawful things as are incidental to the attainment of the above Object.

In reference to the penultimate clause of Object, the following is a statement of the Objects of the British and Foreign Unitarian Association, as set forth in Rule 2 of its Constitution:

The diffusion and support of the principles of Unitarian Christianity, including the formation and assistance of Congregations which do not require for themselves or their Ministers subscription to any doctrinal articles of belief; the publication and circulation of biblical, theological, scientific and literary knowledge related to Unitarian Christianity; the doing of all such other lawful things as are incidental or conducive to the attainment of the above objects or any of them.

The following is a statement of the Objects of the National Conference of Unitarian, Liberal Christian, Free Christian, Presbyterian and other Non-Subscribing or Kindred Congregations, as set forth in Rule 1 of its Constitution:

To consult, and when considered advisable to take action, on matters affecting the well-being and interests of the Congregations and Societies on the Roll of the Conference, as by directing attention, suggesting plans, organising expressions of opinion, raising funds to carry out the foregoing objects



#### **Annual Meetings 2011 - Abstract of Proceedings**

The eighty-third Annual Meetings of the General Assembly of Unitarian and Free Christian Churches were held from Friday 15 to Monday 18 April 2011 at the University of Swansea. The programme of departmental and affiliated society meetings and workshops commenced during the afternoon of 15 April, preceded by the John Relly Beard Lecture delivered by Rev J Eric Jones on "Reflections of a Welsh Unitarian Minister".

The first business session commenced at 15.45 on Friday 15 April 2011 with an opening welcome by Rev Eric Jones. The session was chaired by the General Assembly President, Neville Kenyon. The Standing Orders for the Conduct of Business Meetings were adopted. The Steering Committee, consisting of Joyce Ashworth, Dawn Buckle and Rev Andrew Hill were confirmed with thanks offered to the former members Michael Tomlin and Dr Jane Williams. The President recognised the contribution of past Presidents who were present and welcomed international visitors. Apologies for absence were received from Jean and Bert Inkson, Rev Ann and Rev Arthur Latham, Rev Dr Len and Mrs Joan Smith, Rev Geoffrey Usher, Roderick Ramage and Rev Dr Andy Pakula. Rev Martin Whitell, Executive Committee Convenor, introduced General Assembly staff.

The Convenor presented the Annual Report with Executive those ٥f the Committee. Communications, Education and Training, Faith and Public issues, Denominational Support and Ministry Commissions taken in turn followed by questions. Sir Peter Soulsby was thanked for his work as Convenor of the EC since its inception and Dot Hewerdine and Lis Dyson-Jones, having completed their term of office, were thanked for their contribution. Following dinner, the Opening Celebration took place in the Taliesin Theatre with a focus on the contribution of volunteers to the Movement; locally and nationally. All involved are to be thanked for making the evening such a success.

The second business session commenced at 08.45 on Saturday 16 April 2011. Huw Thomas, Honorary Treasurer, introduced the Annual Accounts for the year ending 30 September 2010. He explained that for the first time the accounts of the General Assembly, Nightingale Centre and Sustentation Fund had been presented in a consolidated form to enable a full picture of the resources available to the General Assembly to be understood. A number of questions were addressed. The Convenor introduced the

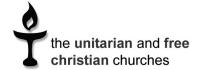
Strategic Priorities that had been developed by the Executive Committee following the "Difficult Choices" consultation at the 2010 Annual Meetings. Presentations of the four Strategic Priorities - Ministry, Visibility, Local Leadership and Improving Services - were received.

The third business session commenced at 11.00 on Saturday 16 April 2011. The Theme Speaker, Fiona Liddell from the Wales Council of Voluntary Action, gave a presentation on Volunteering, with a brief question and answer session. An amendment to Standing Orders was defeated. Huw Thomas presented the report of the Stipend Review Committee Report. A motion to refer back sections of the report was defeated. The report was accepted with an amendment to refer item 7 on mileage allowances to the Executive Committee to take account of recent HMRC changes. That evening a social evening was arranged by Welsh Unitarians - an excellent and memorable occasion.

The fourth business session commenced at 08.45 on Sunday 17 April 2011. A motion congratulating the Unitarian Universalist Association on its 50th anniversary was approved. Michael Tomlin presented the report of the Sustentation Fund and thanked Eileen Wield for her work as Secretary of the Fund over many years. Marion Baker presented the Nightingale Centre report. Changes to the Constitution to address the matter of insufficient candidates being nominated for the Executive Committee election were approved. Rev David Usher presented the Anniversary Appeal. A motion from Oldham Unitarian Chapel on asylum seekers was approved. Rev David Shaw presented the ICCU Founders Vision Award to the Rev David Usher. The contribution of Christine Havhurst to the ICUU acknowledged and she would receive her ICUU Founders Vision Award on another occasion.

The Anniversary Service was held on the afternoon of Sunday 17 April 2011 following a 'Gymanfu Ganu' (Singing Festival) in the Brangwyn Hall, Swansea. The service was led by Rev Anthony Howe and the Anniversary Preacher was the Rev Jeffrey Lane Gould.

The fifth business session commenced at 08.45 on Monday 18 April 2011. Rev Celia Midgley presented the ICUU Founders Vision Award to the Rev Cliff Reed. Rev Martin Whitell reported back on the feedback received on the Strategic Priorities. The Executive Committee had listened



carefully and would be considering all the comments. Generally there had been a positive response. Anyone interested in serving on the new strategic groups was asked to contact the Chief Officer. The President thanked Dot Hewerdine and Lis Dyson-Jones for their valuable contribution to the EC since its inception and wished them well as they stepped down from the Executive Committee. He then welcomed the Rev John Clifford as a newly elected member and Mr Robert Ince who had been co-opted to the EC until the next EC election. A motion on the Charter for Compassion was approved.

The sixth business session commenced at 10.45 on Monday 18 April 2011. Joyce Ashworth presented the outgoing Welsh Secretary, Rev Eric Jones and his wife Mrs Anne Jones with an album of memories from the past 40 years and flowers on behalf of the Denominational Support Commission. A motion congratulating Amnesty International on its 50<sup>th</sup> anniversary was approved. A motion welcoming Undodaidd Bangor Unitarians into membership of the General Assembly was approved with a standing ovation.

The final business session saw the approval of Procedural Resolutions (below). Neville Kenyon gave his Presidential Address. Rev Dr Ann Peart was installed as President for 2011/2012 and spoke to the Annual Meetings on her theme for the year "Exploring the discipline of ordering our lives together" She conducted a closing service of worship.

During the meetings "Celebrating Our Volunteers" videos and a youth programme video were presented at appropriate points as were the General Assembly's IT developments.

The 2011 Annual Meetings concluded at 12:30.

#### Resolutions

The following resolutions were agreed:

#### 1. From - GA Executive Committee

That this General Assembly of Unitarian and Free Christian Churches congratulates the Unitarian Universalist Association on its 50th anniversary as successor to the American Unitarian Association (1825) and the Universalist Church of America (1793).

#### 2. From - GA Executive Committee

That this General Assembly of Unitarian and Free Christian Churches welcomes Undodaidd Bangor Unitarians as a 'small congregation' according to by-law 2.2.

#### 3. From - GA Executive Committee

To amend Paragraph 7 of the constitution, adding new sub paragraphs d and e:

- d. If the number of candidates remaining validly nominated for an election is equal to the number of members to be elected to the Executive Committee, those candidates shall be declared elected unopposed.
- e. If the number of candidates remaining validly nominated for an election is less than the number of members to be elected to the Executive Committee, then –
- (i) the candidates validly nominated shall be declared elected unopposed, and
- (ii) the Executive Committee shall fill any vacancy by appointment within six months from the date the declaration of valid nominations were received. Any such appointed person shall serve until the next Executive Committee election.

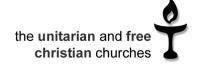
## 4. From - Northampton Unitarians and from twelve individual Full Members

That this General Assembly of Unitarian and Free Christian Churches:

- [1] joins with the Unitarian Universalist Association, the International Association for Religious Freedom, the Dalai Lama, Archbishop Desmond Tutu, Religions for Peace, the Council for a Parliament of the World Religions, the National Council of Churches USA, the Three Faiths Forum, the Earth Charter and other people of goodwill from various spiritual traditions throughout the world in affirming the Charter for Compassion.
- [2] urges our fellow Unitarians & Universalists to reflect on the Charter's vital humanitarian message, inspired by the Golden Rule, and to act in its spirit.
- [3] resolves to become a partner organisation to the Charter for Compassion.

## 5. From - the Unitarian Peace Fellowship That this General Assembly of Unitarian and Free Christian Churches:

- [1] congratulates Amnesty International on the occasion of its 50th Anniversary in July 2011.
- [2] notes Amnesty International's devoted work for human rights and civil and religious liberty worldwide; its determined advocacy of all victims of injustice and political and religious persecution, in particular women, gay people and vulnerable minorities; and its campaigns against the death penalty and judicial injustices.
- [3] requests the Chief Officer to write to Amnesty International expressing our warmest congratulations and encourages our Unitarian congregations to mark this occasion appropriately.



6. From - Oldham Unitarian Chapel

That this General Assembly of Unitarian and Free Christian Churches:

[1] applauds this statement concerning asylumseekers by Kate Wareing, Director, UK Poverty, Oxfam on February 4th, 2011:

"Thousands of people are being forced into destitution as a result of government policies. We must end the policies that lead to destitution, and are unacceptable in the sixth richest country in the world".

[2] recognises that such destitution affects tens of thousands of people currently resident in the United Kingdom;

[3] holds that the United Kingdom government should change policies which lead to destitution and should ensure a fair, efficient asylum system which protects the rights and dignity of all who use it.

[4] requests its Chief Officer to write to the Immigration Minister recommending that the United Kingdom government should:

[4a] provide destitute asylum seekers with support to meet essential living needs: either until they are returned to their country of origin or they are given permission to remain within the United Kingdom;

[4b] provide free access to healthcare for all asylum seekers while they are in the United Kingdom;

[4c] grant asylum seekers permission to work if their case has not been resolved within six months or they have been refused, but temporarily cannot be returned through no fault of their own:

[4d] improve decision making and ensure that all those in need of protection receive it.

[5] encourages Unitarian and Free Christian congregations and every individual Unitarian to write to their own MPs in furtherance of these proposals.

The Executive Committee (EC) met as follows during 2010/11:

The Executive Committee would like to record its thanks to Elisabeth Dyson-Jones and Dorothy Hewerdine who left in April 2011 following completion of their term of office. They were replaced by Rev John Clifford, elected unopposed, and by the co-option of Robert Ince. In May 2011 Sir Peter Soulsby resigned following his election as Mayor of Leicester and he was replaced by the co-option of Cathie Masztalerz in September 2011. Sir Peter is to be thanked in particular for his service as the first Convenor of the Executive Committee.

The Executive Committee act as the trustee body of the General Assembly and is responsible for determining the overall direction and development of the Assembly in pursuit of the Resolutions of the Annual Meeting and the requirements of charity and other legal requirements. It provides strategic leadership and is responsible for ensuring the effective use of the assets of the General Assembly.

In the report presented last year the EC outlined the strategic priorities that had been agreed following the "Difficult Choices" consultation during 2009/10. In September 2010 an overall goal was identified of building "sustainable and thriving Unitarian & Free Christian communities". Four aims were set for the General Assembly recognising the limitations of what was possible at national level:

 encouraging and supporting leadership at local level ("Local Leadership")

- developing Ministry within the denomination ("Ministry")
- raising the visibility of the Unitarian movement ("Visibility")
- improving the services to the movement provided by staff and volunteers ("Improving Services")

The EC set out an objective against which the achievement of the aims could be measured.

"Our objective over the next five years is to become a thriving and increasingly visible liberal religious community throughout Great Britain.

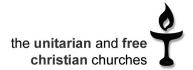
- We will increase our membership by 20%
- We will increase the number of qualified and active Ministers to at least fifty
- We will ensure that all Unitarian congregations can have access to professional Ministerial or recognised lay leadership and support
- We will ensure that all volunteers have access to training and support"

This year is therefore the first of the five years and has in many senses been one of transition. At the Annual Meetings in April 2011 the EC presented the key elements of the strategic priorities plan. These included under Ministry recruitment/interviewing, training/credentialing & settlement; Visibility - religious identity, social justice cause and media skills training; Local Leadership - modular training strategy, advice and facilitation services and Improving Services review of structures, staffing, increasing "live giving" and support for volunteers. Work has commenced across these areas both to put in place the mechanisms for delivery and in specific project areas. These are at early stages given the dependence upon volunteers and a limited staff team.

In the last report a commitment was given to reporting on progress in subsequent reports. In relation to the objective we have assessed the current position as follows:

We will increase our membership by 20%

Currently our only means of measuring membership is the very imprecise quota statistics which are set out by congregation in the Annual Report. How far these actually truly represent the actual membership – which varies across congregations in



definition – is questionable. However, with these caveats, the quota for 2010/11 which drew on membership in mid-2010 shows a reduction of 57 from 3,659 (adjusted to take account of a recording error) to 3,602.

 We will increase the number of qualified and active Ministers to at least fifty

The Chief Officer has prepared an analysis of the number of active Ministers currently working in congregations with a forecast for the years to 2015 based on assumptions about retirement. These show a baseline of 46 (including Lay Pastors) and that the target of 50 within the time period is certainly achievable. The number of applications for ministry training received in the current year is encouraging, and reflects to some extent the changes to selection criteria around age & mobility, and will support the achievement of this target. There are clearly concerns about the number of ministries available and the Ministerial Vacancy list is maintained and currently has a number of full-time and parttime opportunities.

- We will ensure that all Unitarian congregations can have access to professional Ministerial or recognised lay leadership and support
- We will ensure that all volunteers have access to training and support

Plans in these areas are at an early stage. To a large extent this relates to growing Ministerial numbers - with a focus on quality as well as numbers - but also to developing and supporting lay leadership. The Ministry and Local Leadership strategic groups are committed to working together to enhance leadership across the board.

The Executive Committee will be working with the Visibility Strategic Group to identify how it might measure visibility in a meaningful way. There are no easy ways of doing this in numerical terms but success can be demonstrated. It is certainly the case that over the past year the Unitarian movement has achieved more media coverage, primarily as a result of the civil partnerships in religious premises legislation in England and Wales and equal marriage proposals in Scotland, where we have a distinctive stance. It has also proved invaluable in building relationships with a range of like-minded faith and secular groups and raised our visibility in the public arena which should bear fruit in the future. The good working relationships with The Quakers and Liberal Judaism are to be noted.

Much activity during the year has involved the transition from the former structure of Commissions and Panels to the new one of Strategic Groups and Action Groups in order that the efforts and limited resources of the General Assembly might be more clearly focused. All members of Commissions and Panels are thanked for their commitment and hard work over recent years. This remains at varying stages of development as it has involved a bottom-up approach during implementation.

Work has been undertaken to improve risk management processes and to more effectively identify and manage the real risks to the Assembly. A risk register is regularly reviewed. The Executive Committee has referred to the guidance given by the Charity Commission in relation to public benefits when reviewing their aims and objectives and in planning future activities. In particular the Executive Committee members, in their role as charity trustees, have a responsibility to consider how planned activities will contribute to the aims and objectives they have set.

The Executive Committee has continued its efforts to improve communications with the wider Unitarian Movement. The role of "link" has been kept under review. Each member of the Executive Committee has a link to one or more of the Districts, which involves ensuring regular reports are produced on the Executive Committee's work and occasional attendance at District meetings and/or other gatherings. Members also provided a link during the transition from Commissions to Strategic Groups to ensure greater awareness and co-ordination of activities. Key Messages are circulated after each meeting to The Inquirer. The Unitarian and Uni-news. The agreed Minutes of Executive Committee meetings are also available via Uni-news.

The 2011 Annual Meetings had a focus on "Celebrating Our Volunteers". Returning to Swansea, Wales for the first time in many years was a pleasure and the Meetings, particularly the Welsh heritage of culture and song, were memorable. The Opening Celebrations were sponsored by the Foy Society in conjunction with the Denominational Support and Education & Training Commissions. The Anniversary Service was held in the magnificent Brangwyn Hall with Rev Jeffrey Lane Gould as Preacher and Rev Anthony Howe as Service Leader. It was preceded by a 'Gymanfa Ganu' or singing festival and was probably the largest gathering of Unitarians and Free Christians in the 21st Century. The social evening arranged by Welsh Unitarians was an excellent and well-received occasion.

The Commissions, Panels and Unitarian societies and affiliated bodies of the General Assembly took the opportunity to promote their activities and engage with participants to create a vibrant and busy meeting. Training events for congregational officers were provided and proved a popular initiative.

The work of the various Commissions is described in Commission reports. The work on strategic priorities has reinforced the need for greater focus between the Executive Committee, the Strategic Groups and the staff team to improve the effectiveness of our organisational arrangements and reduce duplication.

The Accounts of the General Assembly are set out later in this report. The Nightingale Centre and Sustentation Fund were identified last year as subsidiary charities to the General Assembly and are again included in the consolidated Accounts. The Executive Committee, as a body of trustees under Charity Law, has responsibility to ensure that the finances of the organisation are effectively managed in line with the objectives. The past year has continued to be a difficult period. Income from "live giving" has held up but that from investments has fallen, although capital values have been subject to considerable variation. The expenditure of the General Assembly has come under pressure and the Executive Committee has had to seek to balance the requirements of statutory responsibilities, the need to fund current activity and the spending on new initiatives. Monitoring reports on financial performance were presented to each Executive

Committee meeting along with end of year projections. The budget for 2011/2012 and levels of congregational quota were approved in September 2011. The General Assembly holds sufficient free reserves, not restricted by their purpose or by virtue of endowment, to ensure that it is able to service its annual budgeted expenditure and to ensure that its risks in relation to its pension fund obligations are mitigated

Some initial consideration took place on approaches to fund-raising with a focus on specific areas of activity. The likely demand on the Ministerial Students Fund is an area of concern and has been kept under review with regular forecasting. The EC would like to thank the Honorary Treasurer, Huw Thomas, for his professional advice over the last two years both on financial and other matters and whilst they understand his decision not to seek reappointment in April 2012 are conscious that he will not be easily replaced.

The Executive Committee would like to thank the Chief Officer and staff at Essex Hall for their work and commitment during a period of change. A new development was the appointment of Dr Carwyn Tywyn as Welsh Department Secretary with the support of the Welsh Department and the Welsh congregations. They would like to thank Rev Eric Jones for undertaking this role for many years and also Rosemary Ruston and Louise Rogers for their work on the Associate Members' scheme, which builds relationships between the General Assembly and individual Unitarians.

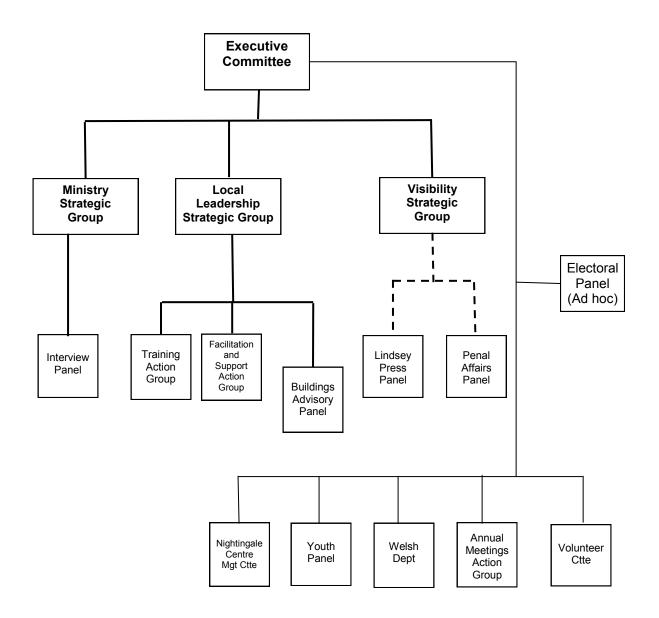

#### **Review of Commissions and Panels**

The Executive Committee has undertaken a review of Commissions and Panels to ensure a focus upon the key strategic priorities. This remains at varying stages of development as it has involved a bottom-up approach during implementation with strategic groups looking at what structures they need to deliver their objectives. During this period of transition groups have developed at a differing pace and there is still much work to do in terms of appointment of some members and gaining clarity in terms of tasks. It is recognised that there has been uncertainty during this period of change.

The following diagram presented the picture as at January 2012 and it is anticipated that there will be further amendments over the coming months.

#### **Mission Statement**

To encourage the growth and development of the Unitarian community by promoting a clear, contemporary Unitarian message via traditional and innovative means, in accordance with liberal values.

#### Meetings

The Commission met three times during the year.

#### Leaflets

The review of leaflets has been completed. Further leaflets have been published, including *Unitarian Views of God*, with the final leaflet, *Unitarian Views of Human Nature*, prepared for publication. Some have been referred to more appropriate commissions, others have been made available on the website. The commission is grateful to those authors who have given of their time to revise and provide content for publications, and also to Kate Taylor who has led on this project, with assistance from Marion Baker (and previously from Janet Eldred). Continued review of the leaflets will be necessary to keep them up-to-date.

#### Online worship

The commission continued to support the National Unitarian Fellowship (NUF) in the pilot project to produce high quality resources for online worship. Equipment purchased as part of this project is being used to film Unitarian material to be put online, as well as the monthly meditation for the NUF website and material for YouTube.

#### **Consistent Identity**

The commission continued to promote implementation of the consistent identity.

The notice board project, which made funding available to congregations to support new notice boards designed in line with the consistent identity, continued to be successful. Forty-five congregations have benefited from the scheme, out of a total of fifty-nine enquiries.

A grant was made to the Bury St Edmunds congregation in support of activities for the 300<sup>th</sup> celebrations.

#### Publicity and promotional activities

The travelling display, launched at the 2009 Annual Meetings, continues to be well-used; a replacement set has been purchased. Some congregations have enquired about getting a set made for use locally.

The bookmarks and chalice badges remain popular. It was decided not to produce further merchandise.

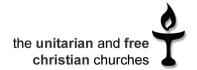
Staff at Essex Hall continue to respond to enquiries, with 149 information packs being sent out between October 2010 and September 2011. The majority of enquiries are received via the national website.

Thanks goes to James Barry for his continued work to maintain and develop the national website, and to the DUWIT team for their work to develop websites for congregations and other groups.

The commission has maintained links with UCCN.

The commission met for the last time in September 2011, when the main focus was a review of work to date in order to produce a hand-over report.

Thanks must go to all those who have served on the Communication Commission, during the last year and throughout its lifetime, giving generously of their time and experience.

The Panel, which met three times during 2010-11, was greatly saddened by the death of Margaret Hamer who had brought a personal grace, enthusiasm and faultless judgment to our deliberations.

The Panel has been pleased that Derek McAuley has attended our meetings and is contributing to our prospective publication list.

During the year, we published one wholly new work, Cliff Reed's *Darwin's Unitarian Connections*, and a slightly revised reprint of Cliff Reed's *Unitarian? What's That?*. This is a guide which we like to think congregations will buy in order to have something to give to newcomers or inquirers. It has been produced at an economic price by Cerberus, a Kendal firm introduced to us by Katie and John.

The year has seen the publication on the General Assembly's web site of many of the out-of-print Lindsey Press books.

We are grateful to James Barry for undertaking the scanning and uploading and hope that this will meet the requests we have had from some students for reprints.

Considerable work has been done by John Harley and Lyanne Mitchell on the prospective folder of UniDoodles and we hope to publish the first twelve sheets during 2012-3. Work is also ongoing on a book which was originally planned to focus on using drama with children but has widened in its scope to include a wide range of suggestions for drawing children into worship services; it will include an item by Margaret Hamer for dramatisation.

Plans for a collection of essays edited by Stephen Lingwood on Unitarian Spiritual Practice and for one edited by Derek McAuley on Unitarian Ways of Living in the Twenty-first century are at a very early stage.

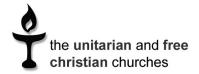

The Juice Bar at the Annual Meetings in Swansea provided ready refreshment for those who needed a quick pit-stop between sessions.

The members listed above have worked diligently in pointing out areas that the new Local Leadership Strategy Group may well want to continue and at a meeting in Manchester at the end of the summer we looked back over much work very well done.

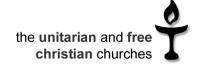

The panel would like to congratulate David Warhurst on his excellent stewardship of the panel prior to him stepping down in September 2010. Marion Baker also left the panel in June 2011 and we would like to commend her for the sterling work she did on behalf of the panel. We wish them both well in their future endeavours.

The panel met three times during the year; at Essex Hall on March 12th; Cross Street, Manchester on September 24th; and Upper Chapel, Sheffield on February 25<sup>th</sup>. Most of their work is done via email and telephone.

The purpose of the Buildings Advisory Panel is to offer clear guidance and practical support on developing, financing, and maintaining congregational buildings and land. The main focus of the panel this year has been on responding to requests for assistance from various Unitarian places of worship which are usually submitted via Unitarian Headquarters.



These have included advising Essex Hall on the upgrading of their heating boilers, Plymouth Unitarian Church on proposed new heating systems, and Octagon Chapel, Norwich on the possibilities of the installation of renewable energy systems.

Mansfield Old Meeting House are still in the midst of their building work and the panel is keeping a watching brief in case further advice is required. Oat Street Chapel, Evesham are also undertaking structural repairs and have had a site visit and advice on funding for the repairs and VAT on building work to listed buildings.

The panel has also had contact with Southend Unitarians regarding their Energyshare scheme.

The panel was also involved in discussions and visits surrounding the closure and sale of the building at Pudsey.

At the March meeting the importance of congregations registering their building with the Land Registry was discussed and it was emphasised that all congregations should do it to prevent land disputes such as had happened in the past with Unitarian congregations.

One of the panel members gave a lecture on church buildings to Yorkshire Unitarian Union.

The panel still maintains its extensive list of consultants and sources of funding and has added a few more during the year.

The panel has maintained its link with the Ecclesiastical Architects and Surveyors Association (EASA) and one of the panel members was able to attend their Summer 2011 Conference. Another panel member has maintained their membership of English Heritage, the Chapels Society, the National Trust, Civic Voice, and the Historic Towns Forum.

One of the panel members is to be congratulated on their election as a parish councillor where they are involved with the planning committee and the tranche of new planning legislation produced by HM Government.

The panel have copies of the National Churches Trust Survey and English Heritage's "Caring for Places of Worship" which they can email to any Unitarian congregation.

## Congregational Assessment Process

Prior to the new working structure commencing at the beginning of October, the Congregational Assessment Process operated under the Denominational Support Commission.

During that time four congregations sought advice about undertaking this assessment process and three resulted in official applications being made. All three congregations completed the full CAP process before the new structure came into being. Joyce Ashworth agreed to continue as Facilitation Co-ordinator until the new system was fully established and a further congregational request for preliminary discussion will take place shortly before the 2012 Annual Meetings.

Congregational Assessment was one of the aspects covered in the facilitation training weekend which took place early in the year at The Nightingale Centre with a view to creating a pool of independent and impartial facilitators able to respond to congregational requests for help and advice with regard to future progress and development.

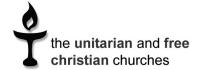
#### **Strategy Statement**

The Project Group has continued to share information between the Districts and it produced a final Newsletter in the spring of 2011.

The District Self Assessment Exercise was modified following feedback from some of the Districts that had carried it out. We presented it again at the Annual Meetings in Swansea to an enthusiastic and interactive group! About half of our Districts have either completed their first or



second runs and some are still in the process of setting up their first attempt. The information that is being collated (by Robert Ince) is giving a clearer view of the activities, strengths and concerns of our Districts and congregations.

Useful information has been gathered throughout the course of the project and this has been shared with the Districts. We are grateful to all who have sent material and information to us. The resources which have been collated will be sent to the Local Leadership Strategy Group but can also be accessed from members of the project.

My thanks to all group members for their energy and determination. Our Districts remain a vital part of our Unitarian life and their contribution enriches what we do at a local level.

The Panel has continued to offer facilitation & support when invited by congregations and Ministers during a year of further consultation and continuing transition as the GA Executive Committee reviewed the work of Commissions and Panels.

From the beginning of October 2012, the work of this Panel will come under the remit of the Local Leadership Strategy Group with a commitment to provide Conflict Resolution training as a priority for members of the Pool of Facilitators to enhance the services offered to our communities.

At this point of transition, thanks must be expressed to the many Unitarians who have contributed to the work of the Panel through its several identities as Review and Support, Partnership Support and

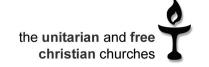

It has been an exceptionally busy and symbolic year for Unitarianism in Wales, including the following key events during 2010/11:

- The nomination of Lis Dyson-Jones as Vice President (and subsequently President) of the GA.
- The visit of Neville Kenyon to both of the districts in Wales.
- The retirement of Rev Eric Jones as Welsh Department Secretary, after 45 years in the post.
- The appointment of Dr Carwyn Tywyn as a new (paid, part-time) Department Secretary.
- The visit of the GA Meetings to Swansea.
- The induction of Undodiaid Bangor Unitarians into the GA.
- Advertising for a Development Officer for the City of Cardiff.



In many ways, this is a transitional period for the Welsh Department. For nearly half a century, Rev Eric Jones conducted the work of the Welsh Department on a voluntary basis. However, Rev Jones was well known to Unitarians across Wales and was therefore a well-established figurehead for the Department.

On the other hand, Dr Carwyn Tywyn is a relative outsider: he only joined the movement in 2005, via the National Unitarian Fellowship (NUF). Nevertheless, the professionalisation of the Department Secretary's role presents new opportunities, not least in terms of visibility and development work.

One further symbolic development was a public meeting on the theme of "The Big Society", held at the National Eisteddfod in Wrexham, in August 2011. Previously, the Welsh Department had only attended alternate *Eisteddfodau* in south Wales.

As Secretary, Carwyn is determined that Unitarianism should break out of its two heartlands, and touch the lives of people in **ALL** areas of Wales. Undodiaid Bangor Unitarians have shown the way forward...

At the time of writing, much work was being done on developing updated constitutions and terms of reference across the various Unitarian structures in Wales, including the Welsh Department Committee itself.

The Worship Panel has in recent years worked mainly in two areas – producing worship material for congregations, and organising worship at the GA Annual Meetings. Both activities require the co-operation of people other than the panel and we acknowledge with gratitude all those who have willingly supported our work.

This year has been a particularly fruitful one for the production of worship packs. The packs usually focus on a significant anniversary or a current theme or issue. This year we produced packs for two anniversaries: the 500<sup>th</sup> anniversary of the birth of Michael Servetus (compiled by Rev Cliff Reed), and the 150<sup>th</sup> anniversary of the birth of Rabindranath Tagore (compiled by Rev Dr. Vernon Marshall).

There were also two theme/issue packs. Being Connected – a worship service to celebrate and reflect on the importance of individual congregations being connected through the General Assembly of Unitarian and free Christian Churches. This was particularly designed for use during GA Weekend. The resolution at last year's GA meetings to be a signatory to the Charter for Compassion provided the stimulus for a worship pack on Compassion. Most of the material in these two packs came from UK Unitarians following publicity in The Inquirer.

All four packs were distributed in hard copy to all congregations and ministers. They are also available for downloading from the GA web site. We gather from informal research that the worship packs are welcomed and, over time, used.

The Worship Panel was responsible, as in previous years, for organising the three early morning worship sessions at the GA Meetings and the short devotions at the beginning of Business Meetings. The Quiet Room at GA Swansea was a multi-stimulus space beautifully arranged by a group of ladies from Aberdare.

This year the Worship Panel shared a double slot with the British IARF committee and explored through a range of activities the life, work and influence of Michael Servetus.

In a letter dated 14<sup>th</sup> March 2011 we were asked to 'complete work currently planned' as the Worship Panel would by September 2011 cease to exist. In fact we started the 'Compassion' worship pack after this instruction, but still had two projects in the pipeline when the end came: a worship pack to celebrate the 350<sup>th</sup> anniversary of the Great Ejection 1662, and a Unitarian Liturgical Calendar.

There must inevitably be an element of obituary in this report. In one of the earliest publications – *Echoes* – the editor, John Midgley said "the need for worship material is a continuing one, to keep in touch with the hopes and pains, the needs and delights of the present day". John was writing in 1982; in the thirty or so years that have passed since then, the Worship Panel (originally subcommittee) has largely met this need. We have considerable creative talent in the movement; we must now wait and see if this can still be harnessed to support Unitarian worship.

#### **Mission Statement**

To provide a framework for education and training within the Unitarian movement which will enhance the development of people of all ages as both individuals and Unitarians.

The Commission met on 16<sup>th</sup> October 2010, 19<sup>th</sup> February 2011 and 6<sup>th</sup> June 2011 (final meeting).

## Officer Workshops at GA Annual meetings at Swansea 2011

Dawn Buckle and Margaret Robinson led a Secretary Training workshop; Huw Thomas and Mike Tomlin led a Treasurer Training workshop; Joyce Ashworth and James Barry led a Chairperson Training workshop and Derek McAuley and Louise Rogers led a Trustees Training workshop.

Despite tight budgets, the Commission continued to work productively and cooperatively, due to being composed of representatives from all the Panels within the Commission. Thus all the Panels were aware of the other Panels' plans and activities, which increased understanding and enabled helpful links to be made. Two grants of £100 each were granted from the Sunday School Income Fund for the purchase of resources for a children's group and an intergenerational group.

#### **Chalice Award Panel**

The Panel were disappointed that they had not received much information about the Chalice Award Scheme being used in congregations despite sending out letters and questionnaires requesting information. Bronze, silver and gold Chalice Award Certificates are available from Essex Hall. Those young people achieving gold also receive a gold chalice piece of jewellery.

#### **Engagement Support Panel**

The Panel has supported two congregations who requested support, and had one request from a District for facilitation training. They celebrated their achievements at their August 2011 final meeting.

**Hucklow Summer School Panel**: Bookings were down as a result of the increase in rates, due largely to the changes in VAT; therefore there were more requests for bursaries to assist people to attend.

Joined Up Education Panel - a National Worship Study Course, Foundation Step was held on four Saturdays in May, June and July 2011 in Manchester. There are twenty participants involved in WSC at present.

Religious Education Co-ordinators Panel - two members of the panel have been involved in the developing and running of REvolution, At present there are 11 District RE Co-ordinators and 71 subscribers to the GA RE e-mail list.

The Help is at Hand handbook written by the Support for Organisational Leadership Panel is available on the GA website, so all leaders of congregations have access to it.

necessary to recruit a new member and, at our last meeting held in Bradford Church, we thanked Joan for all her dedication and hard work over the years before disbanding the Panel and closing the meeting.

#### **Mission Statement**

To offer ministers and lay persons the skills and practices to enable them to facilitate groups/communities that live out right relationship with each other and with God.

#### Scope of Remit

To provide training and give support to those facilitating Engagement groups within the Unitarian and Free Christian community and to promote the value of Engagement groups within congregations and fellowships.

The Panel met on 29<sup>th</sup> March 2011.

The main business of the meeting was to define the distinctive aspects of Engagement Group practice in order that these could be integrated into the modular training plans for Local Leadership and sent to Dot Hewerdine for consideration.

After a process of discussion and re-drafting the following was sent:

It was agreed that the planned Modular Training for Local Leadership would be strengthened by the inclusion of Engagement Support practice and that this should be established and integrated at Foundation level and throughout the various pathways.

We agreed that in defining what is Unitarianism (Foundation A – Volunteering level 1) and its appeal to people of diverse backgrounds and beliefs, it was vital to establish intentional spiritual practices that embrace openness, honesty and commitment because these practices create community and belonging which most people are seeking. We believe this should be made explicit and an understanding of

what is meant by intentional spiritual practice incorporated into the training programme at every level.

Specifics of Intentional Spiritual Practice:

- Understanding relational groups as centres of trust and friendship
- Understanding the group as a centre of hospitality and welcome
- Openness, honesty, trust, respect
- Encouraging spiritual development in a safe setting
- Leadership training needs training in awareness for people's needs for belonging and meaning
- Establishing agreed ways of relating to each other and the regular re-visiting of these agreements
- Understanding how the more task oriented aspects of organisational leadership need practice in this spiritual foundation
- Discovering better ways to serve each other and our community

We also felt that continuity as well as new ideas was important and that someone from this group should be able to take these ideas forward to the Local Leadership Strategy Group.

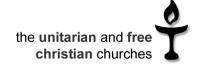
Our final meeting took place at Essex Church, Kensington on Tuesday 2<sup>nd</sup> August 2011 where we celebrated what had been achieved over a period of ten years since Engagement group practice had been introduced to the UK in 2002.

#### **Hucklow Summer School Panel**

#### **Mission Statement**

The core purpose of Hucklow Summer School is religious education: we focus on matters of religion and spirituality and intend to draw out and develop the potential of all participants. We aim to provide a balanced programme, offering a rich mix of activities for both the heart and head, and a variety of optional sessions showcasing a range of worthwhile activities which participants might "take home" and try out in their own congregations and communities. We also ensure that there are plenty of opportunities for relaxed fellowship and fun during the week. Small group activities are at the heart of summer school and provide a safe



environment for deep exploration and personal relating. Morning theme talks provide a contrast in style to the small group activities, stimulate dialogue on religious and spiritual matters, and allow participants to engage with the topic on an intellectual level. Summer School also provides opportunities for daily spiritual practice such as morning meditation and evening epilogues. Summer School brings fellow Unitarians together and allows them to get to know each other deeply and form lasting and meaningful connections. It is our hope that participants will be inspired and challenged to develop and promote high-quality religious education activities when they return home."

The theme of Hucklow Summer School 2011, held from 20<sup>th</sup>-27<sup>th</sup> August, was "Walking the Talk: Living a Life of Greater Integrity". A team of theme speakers gave daily talks on this subject: Rev Gillian Peel, Jef Jones, Rev Sarah Tinker, Jim Corrigall and Rev Linda Hart. Audio recordings of these talks (and those from previous years) are freely available for download from the Hucklow Summer School website at: www.hucklowsummerschool.org.uk

Four different morning engagement groups were offered to adults: "The Web of Life: Seeing and Acting Differently" with Rev Margaret Kirk and Kate Buchanan; "Practising Peace in Daily Life" with Jane Blackall and Jef Jones; "Giving" with Caroline Blair and Rita Woditsch; and "Working With Others" with Mel Prideaux and Winnie Gordon. These small groups met for six two-hour sessions over the course of the week and were intended to give participants an intensive experience of liberal religious education, providing – we hope – examples of best practice in small group facilitation. Our children's programme explored permaculture and was led by Peter Teets and Jim Blair.

Minister of the week, providing pastoral care for participants and supervision for group facilitators, was Rev Elizabeth Birtles. A diverse range of optional afternoon and evening activities were also offered by participants.

This was a slightly smaller summer school gathering than we have recently been accustomed to with 44 adults and 4 children in attendance. Thirty percent of participants were first-timers. We feel that the somewhat reduced numbers were in part attributable to a sizeable increase in our fees, following an unavoidable

change in the way that our payments were handled by Essex Hall, but undoubtedly we have also felt the more general effect of the current economic climate as people have had less money to spend. We will reflect on this in our planning for next year.

The panel decided to dig deep into the summer school bursary fund this year as more people than usual were in need of financial assistance to attend. Year-round fundraising, to keep the fund topped up, will be a high priority for 2012.

Dr Mel Prideaux stepped down from the panel at the end of August 2011, after helping to organise the last three summer schools, and we would like to express our deep gratitude for all she has brought to the team in that time. We are delighted to report, however, that two new members will be joining the panel: Kate Buchanan and Jef Jones. Preliminary planning for the next summer school has already begun. The overarching theme for 2012 will be "Sacred Living" and an application form with details of the programme on offer will be released in January.

#### Core Values

To enable Unitarians to become better informed about Unitarian thought and history and to help equip Worship Leaders with the skills and background knowledge they might need.

A successful Worship Studies Course, (WSC) Foundation Step course was held in Manchester in summer 2011 led by Dawn Buckle and tutored by experienced ministers and lay leaders. 12 participants completed the training and 8 have subsequently received WSC Foundation Step certificates having satisfactorily completed two assessed services. Most of those are now proceeding to the Preliminary Step.

The statistics for 2011 show that 14 people completed the Foundation Step, 8 from the Manchester course, 2 from the Midland Union 2010 course and 4 from the Plymouth course. Also, 3 students completed the WSC Preliminary Step, and 1 student completed the Unitarian Studies Course (USC).



There are 6 students on the WSC Preliminary Step with 5 more from the Manchester course about to join them, 2 on the Preliminary Step of USC and 3 students are on the WSC Advanced Step. The Course tutors, Rev Ernest Baker, Revs Alex Bradley and Rev Dr Vernon Marshall continue to give excellent, helpful feedback to students. A number of participants have been accepted for ministerial training before completing the 3 Steps. All students presently training, bar one, have undergone some WSC training.

The close contact with the Unitarian Association for Lay Ministry continues. Most members of the Panel took part in a discussion session at the Association's Annual Meeting in November.

The Panel has an outline plan for a Foundation Step course for congregational Organisational Leadership and is gathering material for Foundation Step courses in conducting rites of passage. In summer 2012 plans are in hand to run a WSC Foundation Step course in the Midlands, led by Sue Woolley.

The Panel is now awaiting the conclusions of the GA re-organisation to see where its work lies in the Local Leadership Strategy Group's plan.

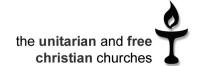
The religious education GA e-mail list discussion group now has 71 subscribers who have joined to share ideas, questions and practical activities on all aspects of religious education.

#### **Mission statement**

"A vision of justice, hope and love for the world. The Faith and Public Issues Commission encourages Unitarians in the United Kingdom to make the vision real by taking action at local, national and international levels."

#### Memberships

The Commission members attended meetings of national and international organisations, representing Unitarians at meetings and conferences including 'Church and Public Issues' at the Churches Together in Britain and Ireland (CTBI) conference, as well as AGM's and some meetings of the following organisations.

The General Assembly (GA) is a member of Accord Coalition, Church Action on Poverty; Christian Aid; Christian Ecology Link; Cutting Edge Consortium Steering Group, Interfaith Network Forum; Jubilee Debt Campaign; the Robin Hood Tax Coalition; United Nations Association; World Disarmament Campaign and the Trade Justice Movement. Where possible the GA has continued to support these organisations through donations, publicity or volunteering.

**Armed Forces Bill – Under 18s**; the Commission worked closely with Quakers in this continuing campaign, attending committee meetings in the Houses of Parliament.

"After a debate on New Clauses 7 and 11 of the Armed Forces Bill, on June 14th, the Government has agreed to introduce secondary legislation so that all those under the age of 18 would have the right to be discharged up to the age of 18. Although the age of enlistment remains 16, the granting of this 'discharge as of right' for under 18s is a significant step in the direction of implementing, fully, the Optional Protocol to the Convention on the Rights of the Child on the involvement of children in armed conflict."

## The Penal Affairs Panel (PAP) is a social responsibility action group of the Unitarians.

The General Assembly created the Panel in 1992 when it had "great concern at the poor conditions and regime at many local prisons." The Panel was instructed "to investigate the current situation on...penal policy, to keep the denomination informed ..., and to provide a liberal religious voice in response... to current legislation."

During the year, the PAP met three times and, just as usual, exchanged many emails. A further PAP Issues Paper, "Breaking the Cycle" on the rehabilitation of offenders, was published as the 12<sup>th</sup> in the series. There was a lively exchange of correspondence (paper) with the government on stopping the War on Drugs. The online PAP News, now in its 9<sup>th</sup> edition, continues to thrive, helping to fulfil the PAP's task of keeping Unitarians informed about criminal justice and penal policy developments. The PAP Network continues to grow. The PAP has a webpage on the GA website where the PAP Issues Papers and PAP News are available to all.

The presentation by the PAP at the General Assembly at Swansea in April 2011 was an address, "Rights or Liberties", given by Dr. Helen Quane of Swansea University. It made a big contribution to the GA2011's success. The address gave rise to an enthusiastic debate on where Human Rights had taken the British people. It became more focused with discussion on the Conservative intention "to bring Human Rights home", that is, reduce the involvement of European-wide courts in favour of British courts and the use of "civil liberties" to safeguard the citizen. This proposal got short shrift after the delegates had listened to Dr. Quane.

The PAP learned in March of the Executive Committee's decision to replace the system of GA Commissions and Panels and was asked to "summarise and celebrate what had been achieved."

From its foundation in 1992, the PAP has battled the spread of harshness in criminal justice matters. In the last year, disillusionment with its tag-line "Prison Works" (and all that has gone with it such as the doubling of both the number of statutory crimes and of sentences) has become widespread and has even found support from the Secretary of State for Justice. The PAP and the Unitarians have much to celebrate about their role in criminal justice affairs.

The PAP has kept up the resistance by Unitarians to the deterioration of the criminal justice system when many others, including Faith groups far more numerous, have given up trying. The Unitarians are becoming regular consultees by official bodies on criminal justice matters. The PAP represents the Unitarians on the Churches Criminal Justice Forum. The PAP has made major contributions on social responsibility motions and debates at recent GA meetings (and has found there to be a large group of Unitarians whose religious beliefs are both embodied in and inseparable from social responsibility actions). The PAP presentations at GA Annual Meetings, with the latest electronic democracy, have reached new, high standards. Its members feel strongly that the specialised work of the PAP must go on.

A major issue for the Unitarians in the future will be our "visibility" and how this might be raised. The PAP sees an obvious answer. Unitarians have been known and are still known for their social responsibility actions – their contributions to social progress. The names of John Howard, Florence Nightingale and others stand out in penal reform. The Unitarian contribution to social progress continues to the present day, such as the major gift of the World Wide Web by Sir Tim Berners-Lee. Above all else, the Unitarians have been known and should strive to become better known for their social responsibility activities.

#### **Ministry Inquiry Days**

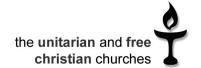
As part of its commitment to ensuring that all those interested in the possibility of ministerial training are well informed, the Commission organised two separate Ministry Inquiry Days in Manchester and London. Similar days will be held this year and all potential candidates are encouraged to attend.

#### **Mentoring System**

A mentor is chosen for each student on acceptance for training and the mentoring relationship continues until the completion of probationary status. This system is administered by the Director of Ministry.

#### Safeguarding

Congregations and their leaders have a legal duty to safeguard both children and vulnerable adults in their care and we remind anyone in either a paid or voluntary leadership position of the requirement to have a CRB disclosure statement.

During the year in question the number of applications received by the Panel was relatively low. Two applicants were called for interview, both of which had a positive result.

In many ways this was beneficial as it allowed the Panel time to look very closely at the process of application and the subsequent work of the Panel. The application form was amended and Panel members attended a day of professional training in interviewing skills which has been immensely beneficial.

The appointment of a Director of Ministry has also allowed a much more professional and focussed approach to how we generate and process applications and to the interview process itself, which has borne fruit in 2012.

The Panel reviewed its policy and offered to give unsuccessful candidates the opportunity to receive feedback if requested. This has been taken up on a number of occasions and, I believe, appreciated.

Application for ministry training is both rigorous and testing for candidates and Panel members alike and much of the information shared is, by nature, confidential. Sometimes people do not understand this and in honouring such confidentiality the Panel is accused of high-handedness and secrecy. All decisions are made after much thought and with due regard to our responsibilities to the candidate, our ministry and our congregations.

During the academic year to summer 2011 eight students were in training:

Harris Manchester College - Jim Corrigall, Sheena Gabriel, Sue Woolley & Lewis Rees.

Unitarian College Manchester - Myrna Michell, Robert MacPherson, Nicky Jenkins & Kath Forder.

We thank those who have since qualified and those who are continuing their training, for their diligence and perseverance and wish them good fortune in their ministries and future studies.

There was just one change of personnel during the year when, following the resignation of Rev John Clifford, whom I sincerely thank for his service to the Interview Panel, Rev Margaret Kirk joined representing the Ministerial Fellowship. I thank all the members of the Interview Panel for their work and their commitment to the future of Unitarian Ministry.

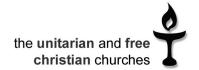


New Ministers welcomed on to the GA Roll this year— L-R: Rev Bob Pounder, Rev Danny Crosby, Rev Daniel Costley

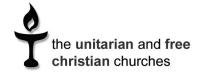

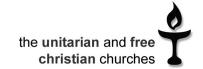

Trustees' Responsibilities in Relation to the Financial Statements

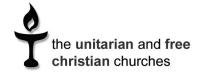

- State whether applicable accounting standards have been followed, subject to any material departures disclosed and explained in the financial statements;
- Prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in operation

The trustees are responsible for keeping accounting records that disclose with reasonable accuracy at any time the financial position of the charity and which enable them to ensure that the financial statements comply with the Charities Act 1993, the Charity (Accounts Reports) Regulations 2008 and the trust deed. They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

## Independent Auditors' Report to the Trustees of the General Assembly of Unitarian and Free Christian Churches

We have audited the consolidated financial statements of the General Assembly of Unitarian and Free Christian churches for the year ended 30<sup>th</sup> September 2011 which comprise both consolidated and charity's Statement of Financial Activities, the Balance Sheet and related notes. The financial reporting framework that has been applied in their presentation is applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

This report is made solely to the charity's trustees as a body in accordance with Section 43 of the Charities Act 1993 and regulations made under Section 44 of that Act. We have been appointed as auditors under Section 43 of the Charities Act 1993 and report in accordance with regulations made under Section 44 of that Act. Our responsibility is to audit and express an opinion on the financial statements in accordance with applicable law and International Standards on Auditing (UK and Ireland).. 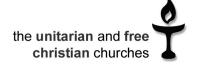

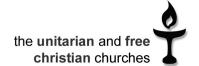

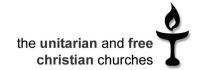

#### Notes to the Accounts for the Year Ended 30th September 2011

#### **Note 1 Accounting Policies**

The financial statements have been prepared under the historical cost convention, as modified by the inclusion of investments at market value and in accordance with applicable accounting standards. In preparing the financial statements the General Assembly follows best practice as set out in the Statement of Recommended Practice 'Accounting and Reporting by Charities (SORP) issued in March 2005 and the Charities Act 1993. The principal accounting policies adopted in the preparation of the financial statements are as follows:

#### Consolidation

The consolidated financial statements incorporate the financial statements of the General Assembly of Unitarian & Free Christian Churches (Registered no. 250788), the Unitarian Convalescent and Holiday Centre at Great Hucklow (Registered no. 242256) and The Sustentation Fund (Registered no. 235449).

#### Cash Flow Statement

The trustees have taken advantage of the exemption in Financial Reporting Standard No. 1 (revised) from including a cash flow statement in the trustees' report and the financial statements on the grounds that the charity is small.

#### Investments

Investments are stated at market value. Movements in the valuation of investments are included with gains and losses on investment assets in the statement of financial activities.

Incoming Resources – Donations, legacies and gifts
 These items are included in the year in which they are receivable, which is when the General Assembly becomes entitled to the resource.

#### • Incoming Resources – Investment income

Income from investments is accounted for in the period in which the General Assembly becomes entitled to the receipt.

#### Resources expended

All expenditure is included on an accruals basis. A detailed analysis of expenditure and allocation between funds is detailed in Notes 3 to 6 to the financial statements. Grant expenditure is detailed in Note 7 to the financial statements.

#### Staff salary costs

Approximately 50% of the full-time equivalent staff hours are spent on programme work. Accordingly total salary costs have been split equally between programme support costs and management and administration costs.

#### • Funds accounting: Funds held by the General Assembly are:

Unrestricted general funds – these are funds which can be used in accordance with the charitable objects at the discretion of the trustees.

Designated funds – these are funds set aside by the trustees out of unrestricted general funds for specific future purposes or projects.

Restricted funds – these are funds that can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor, or when funds are raised for particular restricted purposes.

Endowment funds – permanent and expendable endowment funds are the result of gifts to the charity that are to be invested and the income thereof used for the purposes of the charity either as unrestricted or restricted funds dependent on the wishes of the donor.

Further details relating to each fund is included in the notes to the accounts.

#### Fixed Asset investments

Investments are included at closing mid-market value at the Balance Sheet date. Any gain or loss on revaluation is taken to the Statement of Financial Activities.



Tangible fixed assets and depreciation

Freehold land and property held jointly are not depreciated. The cost of equipment is written-off by equal annual installments over their expected useful lives as follows:

Furniture 5 years Computer equipment 3 years

Stocks – Books, posters, mugs and badges.
 Stocks are valued at the lower of cost and net realisable value.

#### Pensions

The General Assembly operates a defined contribution scheme available to all eligible employees. The assets of the scheme are held separately from those of the charity in independently administered funds. Pension costs charged in the Statement of Financial Activities represent the contributions payable by the General Assembly in the year.

#### Note 2 Intangible income

The General Assembly receives accommodation and services free of charge from Essex Hall Trustees to an estimated value of £50,000 per annum which would have to be paid for if not provided free (See also Note 3).

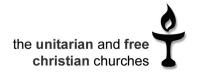
#### **Note 9 Pensions**

The General Assembly operates a defined contribution scheme available to all eligible employees other than Ministers. The assets of the scheme are held separately from those of the charity in independently administered funds.

The Ministers who work for the General Assembly are members of the Ministers' Pension Fund which is a defined benefit scheme. The assets of the scheme are held separately from those of the charity and are administered by the Ministers' Pension Fund.

The last actuarial valuation of the Ministers Pension Fund was at 31<sup>st</sup> December 2010 and showed a deficit of £810,000 (31.12.2007: £266,000) During December 2008 the administration of the Ministers' Pension Fund was taken over by Jardine Lloyd Thompson.

The pension cost charge represents contributions payable by the charity to the defined contribution scheme of £12,121 and contributions payable to the Ministers Pension Fund of £2,523. The amount due for payment at the year-end was £541 (2010: £nil).

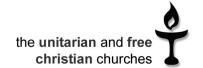

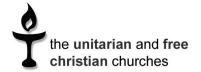

## **The Nightingale Centre**

The Annual Report for the year ending 30<sup>th</sup> September 2011 of the Trustees' of The Unitarian Convalescent and Holiday Centre trading as The Nightingale Centre.

The charity known as The Unitarian Convalescent and Holiday Centre at Great Hucklow in the County of Derbyshire is regulated by a Scheme of the Charity Commissioners sealed 26<sup>th</sup> February 1975. Charity registration number 242256.

**Postal address:** The Nightingale Centre, Great Hucklow, Buxton, Derbyshire, SK17 8RH.

The Custodian Trustee is The British and Foreign Unitarian Association (Incorporated).

The Managing Trustees are the persons who are the members for the time being of the Executive Committee of The General Assembly of Unitarian and Free Christian Churches. The Executive Committee (EC) shall comprise eight persons elected by a postal ballot and an Honorary Treasurer. The Honorary Treasurer will be a voting member of the EC. The EC elections will be held every two years with four members elected at each election to serve for a term of four years taking office at the end of the Annual Meetings following their election.

Under the terms of the Scheme the Managing Trustees may delegate the administrative function of management to an appointed Committee. The Committee, known as The Nightingale Centre Management Committee, is appointed by the Managing Trustees every three years. The ultimate responsibility for management remains with the Trustees.

The members of the Management Committee are: Marion Baker (Chairman), Michael Tracey (Secretary), Gordon Lowthian (Financial Secretary), David Copley, Dot Hewerdine, Richard Merritt and Vanessa Rothwell.

#### **Risk Management**

The trustees have identified and reviewed the risks to which the charity is exposed and ensured that appropriate controls are in place to provide reasonable assurance against fraud and error.

#### **OBJECTIVES AND ACTIVITIES**

#### Objectives and aims

The object of the Charity as stated in the 1964 Charity Commission Scheme is that ' the property shall be used as convalescent or rest homes for persons in need thereof'.

We are currently in dialogue with the Charity Commission with a view to exploring the possibilities of a new Scheme more in tune with antecedent charities of the Children's Holiday Home and of the Florence Nightingale Home and which reflects the current charitable use of the property.

The proposed new objects for the use of the property would include national Unitarian Youth Programme events, Unitarian meetings and conferences, retreat weekends for Unitarians and support for the Unitarian charity 'Send a Child to Hucklow Fund' which provides holidays for underprivileged children.

#### **ACHIEVEMENT AND PERFORMANCE**

#### Charitable activities

The Nightingale Centre has had a good trading year. Our customers have remained loyal, although the number of guests staying at the Centre is lower than last year. Bookings for the forthcoming year are looking healthy and several new organisations will be using the Centre. We did not increase our prices for Unitarians this year and are holding prices until 30 September 2012.

Feedback from all our guests has been very positive about the improvements and the service the centre provides. The staff act immediately to deal with any queries and many improvements are a direct result of guest feedback. This year's good results are a testimony to the energy, commitment and sheer hard work of our excellent staff team lead by the Centre Manager, Stella Burney.

Stella has been working with the Peak Park National Park Authority personnel to improve the Centre's environmental footprint. This has included more cost efficient heating and lighting, solar lighting tubes to bring more daylight into the dark areas of the building, improvements to the garden, including a herb garden, butterfly garden, vegetable garden and composters. The number of waste collection bins has been reduced and we are flushing toilets by



harvesting rainwater. We have benefitted from generous grants from the Sustainable Development Fund towards the cost of these improvements. We are delighted to announce that as a result we have attained the Environmental Quality Mark.

The Centre's Management Committee members give many volunteer hours to ensure the Centre is both a spiritual and practical place for Unitarians to use in enhancing their own contribution to the life of the Unitarian denomination. It is an ideal retreat and training centre for Unitarian activity. We hope that the Centre's value will continue to be appreciated by Unitarians nationwide.

The Centre has a symbiotic relationship with the 'Send a Child to Hucklow Fund' (SACH). We wish the SACH Trustees congratulations for their celebration of the fund's 50th Anniversary and every success in their fundraising. The Centre staff will be encouraging guests to fundraise for SACH with such efforts as Christmas lucky dips, raffles and collections throughout the anniversary year.

#### **FINANCIAL REVIEW**

#### Reserves policy

It is the policy of the Charity to maintain unrestricted funds, which are the free reserves of the Charity, at a level that equates to approximately one year's unrestricted expenditure. This provides sufficient funds to cover management, administration and support costs and to respond to emergency maintenance costs which arise from time to time. Unrestricted funds were maintained at this level throughout the year together with sufficient funds to cover the cost of the building development.

#### **Financial Review**

Despite an anticipated reduction in income due to the current economic climate, thanks to careful control of expenditure by the management team we have achieved a small surplus on our day-to-day activities and generous donations by our supporters has meant that more than £27,000 has been added to our reserves for future operations at the Centre. We are undertaking a programme of major improvements to the Centre thanks to the magnificent legacy from the Estate of Patricia Walker in 2009.

#### **PUBLIC BENEFIT STATEMENT**

The Trustees take into account the Charity Commission guidance on public benefit and believe that the activities of the Centre are in line with that guidance.

## STATEMENT OF TRUSTEES' RESPONSIBILITIES

The trustees are responsible for preparing the Report of the Trustees and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

The law applicable to charities in England and Wales, the Charities Act 1993, Charity (Accounts and Reports) Regulations 2008 and the provisions of the trust deed requires the trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the charity and of the incoming resources and application of resources, including the income and expenditure, of the charity for that period. In preparing those financial statements, the trustees are required to:

- select suitable accounting policies and then apply them consistently
- observe the methods and principles in the Charity SORP;
- make judgements and estimates that are reasonable and prudent;
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in business.

The trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charity and to enable them to ensure that the financial statements comply with the Charities Act 1993, the Charity (Accounts and Reports) Regulations 2008 and the provisions of the trust deed. They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

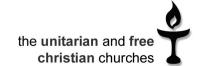

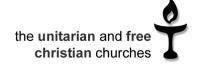

#### Notes to the Financial Statements for the Year Ended 30 September 2011

#### 1. Accounting Policies

#### **Accounting convention**

The financial statements have been prepared under the historical cost convention, with the exception of investments which are included at market value, as modified by the revaluation of certain assets and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008), the Charities Act 1993 and the requirements of the Statement of Recommended Practice, Accounting and Reporting by Charities.

#### Incoming resources

All incoming resources are included on the Statement of Financial Activities when the charity is legally entitled to the income and the amount can be quantified with reasonable accuracy.

#### Resources expended

Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

#### Tangible fixed assets

Depreciation is charged on a straight line basis at the following annual rates in order to write off each asset over its estimated useful life:

Property improvements - 2.5% per annum Fixtures, fittings and equipment - 10% per annum

The original value of the freehold property is not depreciated as, in the opinion of the Committee, it is not worth less than its book value.

#### **Stocks**

Stocks are valued at the lower of cost and net realisable value, after making due allowance for obsolete and slow moving items.

#### **Taxation**

The charity is exempt from tax on its charitable activities.

#### Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

#### Pension costs and other post-retirement benefits

The charity operates a defined contribution pension scheme. Contributions payable to the charity's pension scheme are charged to the Statement of Financial Activities in the period to which they relate.

#### Investments

Investments are shown in the Balance Sheet at market value. Any unrealised gains (losses) are treated as part of the capital of the individual fund.

#### Report of the Trustees - STRUCTURE, GOVERNANCE AND MANAGEMENT

#### 1. Membership and Officers

The Trustees are appointed by the Executive Committee of the General Assembly of Unitarian and Free Christian Churches on a triennial basis, to manage the Funds. The Custodian Trustee is the British and Foreign Unitarian Association (Incorporated).

#### 2. Meetings

The trustees met once during the year on 13th July 2011. The Officers administering the grants maintained a close liaison amongst themselves throughout the year.

#### 3. Public Benefit Statement

The Trustees take into account the Charity Commission guidance on public benefit and believe that the activities of the Fund are in line with that guidance.

#### **OBJECTIVES AND ACTIVITIES**

#### 4. Objects of the Funds

The objects of the Funds shall be to aid in the maintenance of faithful and efficient Ministers and Lay Pastors serving congregations affiliated to the General Assembly of Unitarian and Free Christian Churches.

#### ACHIEVEMENTS, PERFORMANCE AND FINANCIAL REVIEW

#### 5. Annual Accounts

**Sustentation Fund:** The Accounts for the year ended 30th September 2011, showed an operating surplus of £3,415 (2010:Deficit £1,317). After a net investment loss from disposals of £3,274(2010 £41), a year end market revaluation loss of £26,486 (2010: gain £18,283) and investment management fees of £210 (2010: £1,110) there was an overall loss of £26,555 (2010: profit £15,815) for the year.

**Lay Pastors' Fund:** The Accounts for the year ended 30th September 2011, showed an operating loss of £145 (2010: loss of £205). After a year end market revaluation loss of £971 (2010: Gain £508) there was an overall loss of £1,116 (2010: surplus £303).

#### 6. Investments

Newton Investment Management Ltd, continued as Investment Manager and participated with the Trustees in the Unitarian Investment Panel. The investments are held in the name of the Custodian Company of the Bank of New York,1 Canada Square, London E14 5AL, on behalf of the Trustees, and may be held outside the United Kingdom. The Trustees pursue an investment policy which provides revenue for their current purposes and enhances income and capital growth over the longer term, thereby enabling them to meet their current and future objectives in accordance with the purposes of the fund.

#### 7. Grants

Application forms for grants are available from the Secretary via the District Associations. The Trustees meet in June or July each year to consider applications for grants for the year commencing the first of October following. The grants are then paid in quarterly instalments. Applications for grantaid towards the payment of stipends were received for the support of 21 Ministries and 1 Lay Pastorate. Of the 21 Awards made 1 ceased during the year due to the Minister retiring. An analysis of the grants paid in 2010/11 and 2009/10 is appended to the Statement of Financial Activities.

#### 8. Donations

The Trustees are enormously grateful to the providers of donations to the Fund. This year, in addition to the support of a number of individuals - £1,646, the Midland Unitarian Association provided £500 and the Memorial Hall Trustees £500 The total donations received in the year amounted to £2,646 (2010: £1,668).

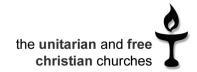
#### Independent examiner's statement

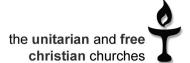
